In producing herewith following two accused persons namely Flinial Dubey of Bow Bazar, near Loha Singh Math, Bottola, PS Bhaktinagar, Dist Jalpaiguri. 2) Kumar Bahadur Darjee (56 years) S/O Lt Jit Bahadur Darjee of South Odlabari, Near Kali Mandhir, PS Malbazar, Dist Jalpaiguri with two white colour dumper vehicle bearing registration WB 78 2687, WB 25E 4400 loaded with river bed materials.

I beg to report that, I ASI Dipak Karmakar S/O lt. Dulal Karmakar of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted persons to the effect that on 14.07.2025 at 21.35 hrs as per source information I along with SI Youel lepcha, ASI Dhruba Mishra, ASI khagen Barman, C/374 Debraj Biswas all of Bhaktinagar PS had been to eastern bypass near Dumping ground under Bhaktinagar PS vide Bhaktinagar PS GDE No- 828 dated 14.07.2025 and found above noted vehicles loaded with illegal river bed materials which was going towards Ashigar under Bhaktinagar PS. On chasing we apprehended the above noted persons with vehicle at eastern bypass near Dumping ground under Bhaktinagar PS.

On further checking the vehicle was loaded with river bed materials. On being asked they disclosed their identity as noted above and further interrogation they admitted their guilt and stated that they are involved in this business of procuring the sand illegally from Sevoke River and transporting the same to different areas as per requirement for illegal gain. On being asked they failed to produce any valid documents/Licence in respect of vehicle or river bed materials.

Accordingly I seized the above noted vehicles along with loaded river bed materials under proper seizure list and arrested them. The whole process of search, seizure took place in between 22.10hrs to 22.45 hrs under properly audio & visual record. I arrested them u/s 35 of BNSS.

Under the above, I pray before your kind end to start a case against the above noted 1) Ajay Dubey and 2) Kumar Bahadur Darjee under proper section of law and caused its investigation.
