Darjeeling, In the State of West Bengal.

That I would like to inform you that I was got married on **10/05/2024** with **Debojit Dey**, S/o Dilip Kumar Dey, as per Marriage Registration vide Certificate No. **WB32800102020600202892-2024-57230** and the name of Marriage officer is **Md. Shahansha Firdoush Alam** and since then we both are living as a husband and wife at my husband residential flat situated at Vastu Vihar Apartment, Block – B, Flat No. 304, Post office & Police Station - Matigara, Dist. Darjeeling, In the State of West Bengal along with my husband and my mother –in- law.

That after some time of marriage my husband behavior is totally change and he started to behave me like servant and started mental torture upon me to leave his above mentioned residential flat and make mental pressure to forgot everything about marriage.

That he i.e., my husband Debojit Dey working in Private Bank and his income is sufficient to provide me the basic needs of Human livelihood but last few months he totally started to ignore me he is neither providing me foods, cloths or medicine, I several time taxes on WhatsApp and try to reached through his phone number vide **9339359487**, but everything went to van and now he totally denied to talk with me and also denied to provide foods and cloths or medicine me and it's become difficult to me to survived without foods and cloths.

That my husband makes many mental pressure to leave his residential flat but I ignored it but later my Sister in law namely **Simmi Sharma**, W/o Balraj Sharma and Niece namely **Priyanka Sharma**, D/o Balraj Sharma came to my above mentioned residential flat and started residing with us and they also started me threatening and teasing me to leave my husband above mentioned flat and started mental and Physical torture upon

me but I any how manage all the situation to protect our relations but everything went to van.

That on **18/06/2025**, at about **06:00 P.M.** my Sister in law namely **Simmi Sharma**, W/o Balraj Sharma and Niece namely **Priyanka Sharma**, D/o Balraj Sharma finding alone me in flat started quarrel using filthy language and beaten me brutally in my body through foots and hand other household items but any how I scape from there and went to Medical officer, Matigara BPHC, Matigara, Darjeeling for my treatment purpose and thereafter finding no other alternative to leave peaceful life I came before you to kindly protect me and try provide me justice and basic needs of my livelihood.

Thus due to this reasons I became helpless finding no other alternative it is humble request to kindly look into this matter and take necessary action/Investigation and register specific FIR of my above mentioned incident.
