With due respect I SMT. MADHUMITA BARDHAN, Wife of- Joydeep Bardhan, Daughter of Jagadish Sarkar of P. C. Sarani, Gopal More, Deshbandu Para, Ward No- 30 of SMC, P.O.- Siliguri Town, P.S.- Siliguri, Dist.- Darjeeling. PIN- 734004 Presently residing at Tinbatti, Sreepally P.O. Siliguri & P.S. NJP, Dist.- Jalpaiguri.

Would like to inform you to the following affect that my marriage was solemnized with the SerialNo.1 on 14.07.2003 as per Hindu Rites and Customs at the paternal house of me , Shaktigarh, P.O.- Siliguri, P.S. NJP, Dist- Jalpaiguri in the State of West Bengal, in the presence of well-wishers, family members, Relatives and Friends of both the parties and the said marriage was registered Under Section 16 of Act XLIII of 1954 at Non Official Marriage Officer at Rajganj Block, Vill- Belakoba, P.O.- Prasannangar, Dist- Jalpaiguri on 28/09/2004, vide Serial No- 16/2004, date of receipt 27/07/2004. It is to be noted that Boubhaat Cetremony was held at Bokul Bhawan, NTS More, Siliguri, Dist Darjeeling. That after marriage the serial No. 1 i.e. my husband took me in the above mentioned address i.e. of P. C. Sarani, Gopal More, Deshbandu Para, Ward No- 30 of SMC, P.O.- Siliguri Town, P.S.- Siliguri, Dist.- Darjeeling. Our marriage was duely consummated in the said address. That, after inception of my matrimonial house the Serial No.1 along with his family members used to start taunting upon the me regarding the Stree Dhan Properties which were given by my parents and my mother in law told me that if she was aware of that she will be receiving properties of degrading quality and products not up to mark then she would not be interested at all to create a relation or give marriage with her son. However my parents had given sufficient gold ornaments as per their capacity, furnitures, utensils, clothings and other items. That the torture upon me by my husband & his family members had gone to the such an extent that they on daily basis threatened me to leave my matrimonial home wilfully otherwise I will be facing dire consequences, when I denied to leave mine matrimonial house, my husband & his family members assaulted me. Despite all the inhumane activities from the side of my husband and his family., I tolerated everything with the hope that good times will come one day. Frequently myin laws used to taunt me that they would prefer or wanted a women who was financially independent and had a job to

sustain herself and also provide to the family for which I asked them to give an opportunity and to continue my study to such an extent so that I will get a job but at that time my mother in law objected me and told me to look after the kitchen and do house chores as the place of a maid. It is to be noted that my mother in law in maximum times used to create torture upon me on the instructions of my brother in law i.e. the Serial No.2 That due to wed lock of us one female child was born on 29/05/2007 . That during pregnancy the Serial No.1 and his family members did not provide proper food medicines and etc. Moreover after birth they expressed their dissatisfaction upon me to give up a female child in lieu of male child and also blamed the female baby that after her coming the Hardware business of the Serial No.1 deteriorating so he needed money for new business of plastic doors and given direction upon me to give money in the business from my parental home but I refused to do the same for which the Serial No.1 mortgaged all gold ornaments of me and started the new business. Therefore no vaccination was provided to female baby at that time because they were dissatisfied with the born of the female baby and no precautions were taken.. However the Serial No. 1 and in laws created physical and mental torture upon me for bringing money from my parental house in this way the, I became feeble physically and mentally. That the business of the Serial No. 1 was going well and I had requested to get release her gold ornaments but the Serial No.1 did not pay any heed upon the words of me on the contrary my husband started sleeping alone in a separate bed. The Serial No.1 always neglected to maintain me alongwith my child. In such scenarios my father started to give Rs. 20,000/- per month in the account through his tenant for the survival of me alongwith my female child on demand of the Serial No.1 and family members. That after all that on 17/4/2025 in the evening time brother in law ( Indraneel Bardhan ) of me, and Serial No.1 himself tried to suffocate me with the help of pillow & grabbed the hands of me with the intention to kill me, but when I succeeded to free myself from the clutches of the Serial No.1 and his family members, the Serial No.1 kicked me on my abdomen and had thrown away me out of the house of the Serial No.1 and threatened me that if I disclose anything relating to such incident or if I lodge any complaint, then they will ruin my life. However I contacted with my parental house through my phone to rescue myself as a result elder brother (Debashish Sarkar) of me and younger brother(Ashish Sarkar) of me alongwith their friend namely Bappa Brdhan immediate visited in the house of the Serial No.1 to settle the matter peacefully but Serial No. 1 and his brother not only misbehaved with them the brother in law i.e. Serial No. 2 of mine became furious and slapped on the cheek of my elder brother for which my family member of mine took me in my parental house, and since then I had started to live at my parental house alongwith my child . but the Serial No.1 and his family member never contacted with me and my daughter or provide any sort of maintenance for our livelihood. In the month of May, 2025 I visited in the matrimonial house to save my marriage tie but they drove me by saying that if I'm able to take Rs. 5,00,000/- from my parents for the business of my husband then they will allow me to stay in their house as the wife of the Serial No.1 and retaining mine all belonging / streedhan properties with them.
