Taslim and wife of Mohammed Taz, Resident of Khalpara, Swami Nagar Colony, Near Kali Mnadir, Ward No-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling do here by lodge this F.I.R Against My Husband Namely Mohammed Taz Son of Md. Jhangir and other in laws namely 1. Md. Jhangir son of unknown 2. Baby Bano wife of Md. Jhangir 3. Sahista parvin@Punam daughter of Md. Jhangir 4. Sagufta Parveen@Rajni daughter of Md. Jhangir 6.Md. Raj daughter of Md. Jhangir they all are my mother-in law, sister in laws and brother in law all are resident of Motibag, karbala Busty, near eid gah, ward no-7, kishanganj, P.O & P.S-Kishanganj, in the state of Bihar before you to stating that on dated-9/12/2018 my marriage was solemnized at my parental house situated at Swami Nagar Colony, Near Kali Mnadir, Ward No-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling with Mohammed Taz and after my marriage I live with my husband at kishanganj in the state of Bihar but passing some days I came to know that my husband he was jobless and nothing do any work, his father say me that if my father give him Rs.1,00,000/-(one lac) for starting new business of lottery and my father gave him Rs.1,00,000/-(One lac) in cash for starting business, but he did not start business by this money and started torturing me physically and mentally by many ways, in the year I gave birth a baby boy in the year 2019 at my matrimonial house. Further I state that all his family members pressurized me for doing hard work and household work in their house when I denied to do hard work then all the family members assaulting me in physically and mentally, they did not give me food many time and for the reputation of my family I did not share any incident to my family mother and father. In this year he again started torturing me when I denied to gave them money to them then my husband slap me in front of his family members and his mother and sister's hold my hair to throw out from my matrimonial house but the local people save me. My husband hurrahed me sexually also, ago six month he took me at siliguri along my son for doing job in siliguri, we live together in a rented house in Vivekananda nagar, koyla depo ward no-7 of SMC, under Siliguri police station, in the house of

Now I left the rented house and live with my parental house and he did not give me any expances he along with his family members threatened me that my husband do another marriage with another girl and also threatened me that if I came again their house then they kill me .

So I request before to that kinadly register my complaint as F.I.R against my husband and his family member's and punished them as per law from your ends.
