

With due respect, producing herewith one following accd person namely Paritosh Chandra Roy (32 yrs), S/O Dhano Chandra Roy of Gopinathpur, Kachhari Para, PO. Buri Pukur Hat, PS. Badarganj, Dist. Rangpur, Bangladesh (Not Verified) under arrest, I SI Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Paritosh Chandra Ray (32 yrs), S/O Dhano Chandra Das of Gopinathpur, Kachari Para, PO. Buri Pukur Hat, PS. Badarganj, Dist. Rangpur, Bangladesh (Not Verified) to the effect that on 15.07.25 at 16.10 hrs, I received a specific secret source information that one being suspected as Bangladeshi National, found moving suspiciously at Dagapur area under Pradhan Nagar PS. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 933 dated 15.07.25 and informed the matter to you. As per your kind order and direction, I along with, ASI Biplab Kr Das and force all of Pradhan Nagar PS left for Dagapur by Govt vehicle with investigation kit to verify the veracity of the information vide Pradhan Nagar PS GDE No. 934 Dated 15.07.2025 and M.C.C. No. 1537 Dated 15.07.2025. At around 16.45 hrs, we arrived at Dagapur and contacted my source and at around 17.25 hrs being identified and shown by the source, I noticed that one person coming from Salbari Side and proceeding towards Darjeeling More. Accordingly, we managed to apprehended the person at Dagapur football ground under Pradhan Nagar PS, Dist. Darjeeling.

On interrogation he confessed his guilt and disclosed that he is originally a Bangladeshi National. He hatched up a plan and he entered in India on 13.11.2024 illegally without any valid document (Visa & Passport) with the help of one Bangladeshi agent via Hili Border, Dist, Dakshin Dinajpur with an ulterior motive and stayed in different places of West Bengal concealing his original identity. As he violated the provisions of Indian foreigners Act. Accordingly, I arrested him under proper memo of arrest and observing all the formalities of arrest, informing him regarding the ground of his arrest.

Later he revealed that he is the permanent resident of Gopinathpur, Kachari Para, PO. Buri Pukur Hat, PS. Badarganj, Dist. Rangpur, Bangladesh, and his other family members still reside there. His mother's name is Radha Roy, elder brother's name is Amal Chandra Roy (39 yrs), Sister's nameis Sabitri Rani Roy (35 yrs), Wife's nameis Silpi Roy @ Rima (28 yrs), daughter's nameis Himu Roy (07 yrs), Tulip Roy (04 yrs), and Son's name is Ishan Roy (02 yrs).

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Paritosh Chandra Roy (32), S/O Dhano Chandra Roy of Gopinathpur, Kachari Para, PO. Buri Pukur Hat, PS. Badarganj, Dist. Rangpur, Bangladesh under proper section of law andits investigation may kindly be arranged.
