Post center of city declaration while searching found password changed; ~~am~~ immediately called N.T.A, they advised to put a new password. After that found center changed from Siliguri to Kolkata surprisingly medium of question paper has been changed to Bengali insted of English. The moment I took the photo of that admit my Mob locked by hacker. The moment my son sent a masage to his mother all mobile locked.

On ~~1st~~ 1st May after sending mail to our honourable M.P Raju Bist regarding the issue received threat message that they will hack all official and un official mail of Raju Bist, they will sent twenty people with weapons to attac my son Aryan Mitra in result my son could not appar in the Neet Exam.

They have given advance threat of Nect (2026) which is the main motive, reason was very high marks achieved my son on Allen mock test 716 out of 720

They claimed there regularly meeting with C.B.S.E spy officials and reduced marks of my son of class board regarding which already intimated to C.V.O Mr. Vivek Kumar Singh.

Today on 15th July at around 3.30 am to 4.30 am they have thrown chemical from ventilator inside my ~~son's~~ sons room to kill him and my son immediately fallen sick. Siliguri police visited my residence and collected the chemical for testing along footage.

Mr. Mukesh Kumar who was a broker and uniform supplier sitting at Kota, Kurhadi Landmark city opposite of Allen Sanggar building, who admitted my son Arihant Public school who was ~~at the~~ having all the document of my son now operating as hacker claimed by there team, formed a local team in siliguri who are continuously following our movement, sending details of my sons location to make us mental patient.

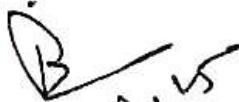
They have inserted two microchip at my residence which not only claimed, later on proved by them, following every activities of our family.
