Subject: Filing of FIR against Mr. Sundar Paswan and Mrs. Paswan for Harassment,
Physical Assault, and Threatening Conduct

Respected Sir,

I, Mr. Pritom Lahiri, residing at E-1 Diamond Block, Prestige Enclave, Sastri Nagar, Siliguri, respectfully wish to lodge this First Information Report against my neighbors Mr. Sundar Paswan and his wife for repeated harassment and physical assault on me and my wife, Mrs. Purobi Lahiri.

Mr. Paswan has continually parked his four-wheeler in the entrance passage and the common space designated for two-wheelers, despite having ample space in his own allocated parking. This ongoing obstruction violates residential norms and endangers the safety and access of the other residents.

On 13/07/2025, at about 6.05 pm when I respectfully requested Mr. Paswan to remove his vehicle from the exit passage, he arrived after approximately thirty minutes and responded aggressively. He said, "If you want to live here, you have to cope with this type of situation," and initiated a verbal argument.

Soon afterward, his wife approached me with the intent to hit me. When my wife asked her to stay away from me, Mrs. Paswan shoved her with force and assaulted her with fist and blows first in her chest, and then in the region of her womb—despite being aware that my wife is eight months pregnant.

Alarmed by this violent behavior, I began recording the incident using my mobile phone camera. Mr. Paswan then physically assaulted me, hitting me repeatedly until my phone fell from my hand.

The entire altercation is captured on my phone, which serves as recorded evidence.

I request the police to take immediate and appropriate action against Mr. and Mrs. Paswan for:

- Obstruction of common property
- Verbal and physical harassment
- Threatening behavior
- Assault on a pregnant woman
- Physical assault against me

We fear for our safety and well-being and urge your office to take necessary legal steps to ensure justice and prevent further incidents.
