I, Md. Faiyaz Ansari, son of Fida Hussain Ashrafi, residing at Ashraf Nagar, Buddha Mandir Road, Gital Para, Ward No. 40 of Siliguri Municipal Corporation, P.S. Bhaktinagar, District Jalpaiguri, would like to lodge a formal complaint regarding a case of theft committed by my employee Atawal Alam, son of Hafizul Rahman, in criminal conspiracy with Sohail of Koiladepu.

Atawal Alam had been working at my biryani shop located at Sevoke Road for the past 1.5 months. He was being paid a monthly salary of Rs. 20,000/-, excluding housing and food allowances. For convenience, I had allowed him to stay at my godown, where several car parts belonging to my father were kept.

Two days ago, Atawal Alam suddenly left for his hometown without prior intimation and later informed me that he had an emergency. His abrupt departure raised suspicion, prompting me to inspect the godown. Upon checking, I discovered that several car parts were missing.

When I contacted him and asked him to return, he demanded Rs. 2,000/- for his return. I told him to come in person and collect the money. Today, he returned and deceitfully took the keys to the biryani shop, where a few more

All these acts were committed by Atawal Alam in criminal conspiracy with Sohail of Koiladepu, and some others with the intention of wrongful personal gain.

Therefore, I request you to kindly take necessary legal action against the culprits involved.

I am ready to cooperate fully with the investigation and provide any additional evidence or documentation as required, including CCTV footage.
