I Smt. Kumari Shilpi W/o- Sundar Kumar Paswan, resident of Flat No.E3 block Diamond, Prestige Enclave, Shastri Nagar, Near Radha Krishna Complex, Bhakti Nagar Siliguri, do hereby write you the following for your kind information and necessary action as follows:

- 1. That I am a law-abiding citizen of India and have been residing at the captioned address since 2016 to till yet.
- 2. That on the 13th day of July 2025, at around approx. 5:30 P.M., a person named Nil Lahiri (Son of Accused No.1 & 2) came to my house and told me that his father, Accused No. 1) was asking about me at the parking, and accordingly, I reached the parking.
- 3. That when I reached the parking both, the accused were there and they started abusing me in filthy language and also tried to assault me physically.
