**Sub: General Diary in the event of attempt to snatching of mobile phone- matter reg.**

I, Binita Sewa w/o Shri Durga Charan Mangraty, resident of Pragati Path, Jyotinagar, Ward-41, P.O- Sevoke Road, P.S. Bhaktinagar, Siliguri-734001, am writing to formally lodge a complaint regarding an incident of attempted mobile phone snatching that occurred with me on 16.07.2025 at around 12:28 P.M. near Dr. M.K. Sharma Skin Clinic at Pragati Path, Jyotinagar.

Today while I was going to pick up my sons from Don Bosco School, two unidentified men on a black scooty approached at high speed from opposite side and attempted to snatch my cell phone from my hand. These two men on black scooty had been waiting right in front of Dr. M.K Sharma skin clinic near my house and as soon as I neared them they started their scooty and came towards me and tried to snatch my phone which fell on the ground and these two men sped past my house.

The entire incident has been captured on CCTV footage of my house from two different angles and I am prepared to share the footage with the police for investigation and identification purposes. I am enclosing two screenshots of the two men on scooty as taken from the CCTV footage from my house.

I believe this is a serious matter concerning public safety, and I request you to kindly take prompt action by registering my complaint and initiating an enquiry based on the video evidence. I humbly request you to take appropriate action and help ensure such incidents are prevented in the future.
