Subject:- Lodging FIR regarding submission of fake affidavit and fake marriage card in Court, Causing defamation & mental harassment, fraudulent act's, cheating, and misuse of legal documents by md. Faisal Ahmed, Manzoor Ahmed, and misconduct by advocates Rajashree Chakraborty and Nobonita Sen.

Respected Sir/Madam,

I, Sabina Khatun, w/o - md. Faisal Ahmed, D/O - md. Ibrahim. Residing at Lower Bhanu Nagar, Leninc Sadani Road, w.No-43, Siliguri near- Agrabot Sangha club, PO - Serake Road, PS - Bhaktinagar. Dist - Jalpaiguri, 734001. wish to lodge a complaint regarding serious offenses involving forgery, cheating, and misuse of legal documents.

- (i) md. Faisal Ahmed, S/O - Late - Masrur Ahmed. Presently residing at ward No-5, Bari Borna, PO - Borna, PS - Chogri, Dist - Khagaria, Bihar. Pin - 851202, OR Aashiyana Apartment, ward No-06, Chaknora Road Dharampur D-Samastipur, Bihar. Pin - 848101.
- (ii) Manzoor Ahmed, S/O - Late - Imamuddin Ahmed, residing at ward No-05, Bari Borna, P.O - Borna, PS - Chogri, Dist - Khagaria Bihar, Pin - 851202.
- (iii) Two Advocates of Siliguri Court, namely Rajashree Chakraborty and Nobonita Sen, both practicing at Siliguri Court, District Doojelling. (Reg. No - 093/2024, Licence No:- 172/RM)

I would also like to clarify that my marriage was solemnized on 31/06/2024 under the Special marriage Act, 1954 through court marriage, and on 23/06/2024, a social marriage.

was conducted through government Qazi Nama.

Now my husband md. Faissal Ahmed with the intention of obtaining a divorce, has illegally conspired with advocates to prepare and submit ~~for~~ forged documents in court to falsely portray me as guilty and to cause me mental, social and legal harm. This act falls under cheating, forgery, and criminal conspiracy.

I would like to bring to your notice that a fake affidavit and a fake marriage card have been prepared and submitted in court without my knowledge and consent. This act has caused serious harm to my dignity and mental peace.

I am a muslim woman, and in the said fake affidavit, the name of the boy mentioned is a Hindu, making it clear that the affidavit and the fake marriage are completely false and illegal. These documents were prepared and submitted by my husband by my husband without the knowledge or consent of my father or my self.

On 12/06/2025, my husband md. Faissal Ahmed created a false affidavit in Siliguri court (Dist. Darjeeling), using a forged signature of my father, md. Ibrahim, without his knowledge or physical presence. This affidavit was notarized by Advocate Rajshree Chakraborty (Reg No - 093/2024, Licence No. 172/RM) and Advocate Nobonita Sen, without verifying the identity or presence of the deponent.

On 12/06/2025, Faissal Ahmed and Manzoor Ahmed come to Siliguri but instead of appearing before the Salpaiguri court, they created and carried fake documents against me which clearly proves their criminal mindset.

They have misused my father's Aadhaar Card by forging his signature and creating a fake affidavit using that document, when I came to know about this matter and ~~approach~~ approached them to seek clarification, they started threatening me and warned me to leave the premises immediately or else they would call their.

People. Following this, I filed a complaint against them at the Siliguri Bar Association, a copy of which is attached herewith for your reference. This fraudulent affidavit was later submitted by my husband in Khagaria family court as evidence against me, due to which my position in the case was unjustly weakened and I was portrayed as guilty. This caused severe damage to my personal reputation, dignity, and mental well-being.

I Request you to:

1. Lodge an FIR against Md. Faisal Ahmed, Manzoor Ahmed, Rajar Shree Chakraborty and Nobonita Sen.
2. Investigate the affidavit dated 12/06/2025.
3. Take strict action against the persons involved under the applicable law.

I ~~forgot~~ am ready to provide a copy of the forged affidavit, the fake marriage card, and related evidence.

This act of preparing and submitting fake documents in court amounts to forgery, cheating, using a forged document as genuine, advocate professional misconduct and defamation, and is an offence.

This fake affidavit is made by my husband and without concern of my father, the affidavit has been identified by advocate and notarized at Siliguri court.

Kindly treat this matter as urgent and take necessary action as per law.

Attached ^{fake marriage card,} Siliguri Bar Association received copy, marriage certificate, government gazinama, Bhaktinagar launched FIR copy, false affidavit copy. A fake marriage card in my name was sent to Md. Imamuddin on 09/06/25 via speed post (EF763213947IN). Kindly investigate this as well.
