This is to inform you that, I Sri Gautam Saha, Son of Late Prakash Chandra Saha, resident of A.P.C. Sarani, Deshbandhupara, Ward No.29, P.S. Siliguri, Dist. Darjeeling. I am the owner of the **HOTEL PRAKASH** which is situated at Hill Cart Road, Opp. Bata Shoes Showroom, P.S. Siliguri, Dist. Darjeeling – 734001.

That my permanent office staff Suresh Sharma, Son of Narendra Sharma, residing at D.B.C. Road, Deshbandhupara, P.S. Siliguri, Dist. Darjeeling, Pin – 734005 who is working almost 35 years in my above mentioned Hotel as a staff. That on 15-07-2025 at about 10:15 P.M. after closing above mentioned hotel he was waiting for someone at near Niladri Hotel, Hill Cart Road at that time one Two wheeler Bike (Pulsar NS400) bearing Regd. No.WB-74-BU-7457 recklessly and by over speeding hit to my aforesaid staff and he fall down on the road and sustained serious injuries in that moment the local peoples stop the said motorcycle and grab the driver named as Manos Majumder and pillion rider Anup Ghosh and the local people immediately take my said staff namely Suresh Sharma to the Siliguri District Hospital for his treatment and also informed me about the incident, after reaching the hospital, the hospital authority immediately referred him to the North Bengal Medical College and Hospital for his better treatment thereafter I directly admitted him to the Siliguri Anandalok Hospital. Thereafter said private nursing home at about 01 am on 16-07-2025 informed me that my said staff namely Suresh Sharma was passed away and it also came to know that the said persons who is riding the offending motorcycle is under legal riding age.

That because of reckless driving and over speeding Manos Majumder and Anup Ghosh my said staff namely Suresh Sharma died in the said accident, so I request to your good offices to take strict legal action against the said Manos Majumder and Anup Ghosh and the owner of the motorcycle bearing Regd. No.WB-74-BU-7457.
