On dated 14th July, 2025 (time: 9:39 pm), I had received a call from 9302774151 (named Abhishek Sharma) pretending YONO Customer Service and took the details of my State Bank of India 's account number, ATM number and its PIN, which I shared with him. And on next day dated 15/07/2025 (time: 6:30 pm and 8:30 pm), I had received two different sms regarding an unauthorized withdrawn of two transactions of ₹4,39,000/-(UTR: SBINR12025071592227212) and ₹1,90,000/- (IMPS Ref No: 519620946045) total of ₹6,29000/- from my bank account bearing the number 20059397758 maintained at State Bank of India, Kurseong Branch. I have neither authorized this transaction nor shared any OTP with anyone.

I believe I have been a victim of a cyber fraud/scam. I have already reported the matter to my bank, and they have advised me to approach the cyber crime cell for further investigation and action.

I request you to kindly register my complaint, investigate the matter, and take appropriate legal action against the unknown fraudsters. I am attaching copies of my ID proof, bank statement showing the fraudulent transaction, and other relevant documents for your reference.
