1. That my grand son Jairus Roy who is studying in
class VII (7) in Don Bosco School, Siliguri has been taking
tuition for computer subject from one teacher namely
Arvind Jha, S/o not known, resident Swamiji More, Hakimpara
P.O & P.S. Siliguri Ashigan Dist Jalpaiguri since past 2 months.
2. That on 13/07/2025 at 11:30 am while my grandson was in
tuition class, the computer teacher out of no were suddenly
started beating up my grand son so badly on both the cheeks
near the ears that he suffered severe pain and swelling injuries.
As soon as my grand son returned home from tuition he started
crying and informed us about the whole incident. Immediately
I called up the teacher and asked him regarding the matter
but he rudely and reluctantly slammed the phone. As a
result of the said beating my grandson has suffered serious
and severe injury on both the ears and is under going medical
treatment from the doctor.

I, therefore humbly request your good self to lodge
this complaint against this teacher in your Police Station and
appropriate action may kindly be taken
