Subject: Taking appropriate legal action against Anil Agarwal and Birendra Agarwal, both sons of Lt. Mangturam Agarwal of Sri Ram Palace, Ward 9, Khalpara, P.O. and P.S. Siliguri, Dist. Darjeeling.

Sir,

With due respect this is to inform you that I, Sri Amit Agarwal, S/O Late Narendra Kumar Agarwal, Resident of Ward No. 9, Sri Ram Palace, Agrasen Road, Khalpara, Siliguri - 734001 that Anil Kr. Agarwal and Birendra Agarwal both are my uncles.

That the property in dispute was joint property since long during the lifetime of my father and we are residing there but dispute have been crocked up between my younger brother Sri Sumit Garg and my uncles and my younger brother Sumit Garg and my mother Punita Devi Agarwal filed one Title Suit against them (my uncles) before the Ld. Civil Judge (Senior Division) at Siliguri, vide Title (Partition) Suit No. 3 of 2025 and the Ld. Court was pleased to grant ad-interim injunction order in favour of my younger brother and mother. Please note that I have no enmity/dispute with both my uncles.

That the dispute is between my uncles and my younger brother Sumit Garg and I am in no way connected to or involved in the said dispute but unfortunately, my uncles are trying to implicate me in a false criminal case so that they can give a lesson to my brother and mother but I became surprised that they lodged a complaint against me and my wife Smt. Vandana Agarwal and they filed a specific false case against my wife and including me stating inter-alia that on 1st July, 2025 at the 2nd Floor of my premises when my uncle Anil Agarwal along with his staff was bringing some catering goods downstairs. Several efforts have been made to make them understand that the staircase is for common use and also to resolve the dispute if any but all has failed and moreover it is a matter of sub-judice before the Ld. Civil Judge (Senior Division) at Siliguri but I become astonished as to how me or my wife are implicated in this alleged incident as because on 1st July, 2025 I was on a business trip to China and I have enclosed proof of the same for your perusal and kind consideration.

It is pertinent to mention that my uncles are creating pressure upon me so that my brother withdraws the case pending before the Ld. Civil Judge (Senior Division) at Siliguri and another case lodged by my brother against my uncles for illegal construction before the Siliguri Municipal Corporation and ultimately filed a Writ Petition Before the Hon'ble Calcutta High Court, Circuit Bench at Jalpaiguri. I have heard that demolition order has been passed by Hon'ble High Court and execution order has also been passed. I fail to understand why my uncle has been creating pressure upon me to withdraw all the cases. I have no good relationship with my younger brother after demise of my father in 2008.

The Today morning at about 8:15 AM all of a sudden my elder uncle Birendra Agarwal along with 8 to 9 miscreants under his command entered my house forcibly and started shouting and using filthy languages upon me entreated my mother who is a 66-year-old widow lady and asked her to withdraw the case otherwise they will not hesitate to kill me. Luckily at the time I was at puja room situated upstairs and hence they couldn't find me and ultimately left my house with a threat that they are the man of B.J.P party of Ward No. 9.

Sir, I am a businessman, and I reside with my wife and two sons and apprehending danger due to such continuous threatening and my uncles those who are politically influential and having connections with social miscreants/anti-social people. I have CCTV camera in my house and entire incident has been recorded.

You are therefore requested to take appropriate legal action against the abovenamed persons to protect my life, property and family.
