DURING INSPECTION IT HAS BEEN OBSERVED THAT KRISHNA ROY (PRESENT USER), CONSUMER ID: 401524077, METER NO: 061883TB HAS EXTENDED POWER SUPPLY TO A DEEMED DISCONNECTED PREMISES OF KRISHNA ROY HAVING CONSUMER ID: 401524076, METER NO: 060809TB CONTRACTUAL LOAD 0.23 KVA.

HERE IT IS FOUND THAT KRISHNA ROY (PRESENT USER) CON ID: 401524077 IS EXTENDING ELECTRICAL ENERGY UNAUTHORIZEDLY & ILLEGALLY TO A DEEMED DISCONNECTED PREMISES OF KRISHNA ROY OF CONSUMER ID: 401524076, METER NO: 060809TB, HAVING UNPAID OSD AMOUNTING RS: 9319.00, WHICH IS VIOLATION OF LAW AND PUNISHABLE UNDER SECTION 135.1(E) OF ELECTRICITY ACT. AS PER SYSTEM REPORT DISCONNECTION WAS EFFECTED ON DATED 13.02.2024.

HENCE PREPARE NOTICE, INSPECTION MEMO BY MENTIONING ALL MINUTE DETAILS, AS OBSERVED AND ALSO SEIZED THE METER IN QUESTION AFTER PREPARING THE PROPER SEIZURE LIST DULY SIGNED BY WITNESSES AND REPRESENTATIVE OF THE PREMISE OWNER. SUPPLIED COPIES OF REQUIRED DOCUMENTS TO THE REPRESENTATIVE FOR FUTURE REFERENCE. REMOVED THE METER FROM THE PLACE AFTER OBSERVING ALL TECHNICAL FORMALITIES.

SO IT IS REQUESTED THAT A CASE UNDER SECTION 135.1(E) FOR KRISHNA ROY (PRESENT USER) MAY PLEASE BE REGISTERED AND ARRANGE FOR ITS INVESTIGATION.
