I, Babli Khatun W/o Md. Anzar, daughter of Md. Bablu of 208, Uchal Pokhri,
P.O. Chengrabanda, P.S. Metliganj, Dist. Coochbihar, (W.B.), Pin-735301 beg to
report you the following facts:-

1. That Md. Anzar, S/o Md. Aslam of Malbazar, Bataigol Bazar, Hat Khola,
P.O. & P.S. Mal, Dist. Jalpaiguri is my legally married husband. My
marriage was solemnised with him on 22-08-2016 at duly registered
before the office of the Mohammedan Marriage Register and Kazi
under the Muslim Marriage Act vide Registration SL No.8/22/8/16
dated 22-08-2016 and after the marriage we lived and cohabited
together as husband and wife.

After marriage I started to live/reside at rented house at
Darjeeling more, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling together as
husband and wife and out of our lawful wedlock, one male child was
born on 27-10-2017 whose name is Md. Aayan.

After few days my husband started to torture upon me both
physically and mentally in different ways day by day.

He always used to physically assault me by fists and blows and by
kicks and always use to pick- up quarrel with me without any reason
and use to abuse me by filthy and insulting languages. Due to his such
continuous physical assault, I sustained injuries on my person several
times and I digested and tolerated pain on my body and the aforesaid
tortures silently.

2. That today i.e., 18-07-2025 at about 4.00 P.M. he along with 3 and 4 his
associate assaulted me by fists and blows very cruel manner in front of
the Pradhan Nagar PS. Main Gate, any how I saved from their hands

and due to such continuous assault upon me in such cruel manners, I sustained severe injury on my persons and I was medically treated to the Siliguri District Hospital, Siliguri, Dist. Darjeeling and still I am under medical treatment.

3. That due to my serious illness caused due to such assaulted by him upon me delay is caused for lodging this FIR which may kindly be condoned.
4. That the Xerox copy of the said Medical paper is enclosed herewith for your kind perusal.

I therefore request you to kindly take necessary steps against the aforesaid culprits i.e., against my husband and his associates for the commission of the aforesaid offences upon me.
