and threats by ~~male~~ brother-in-law.

Respected Sir / Madam.

I am writing this letter to file a formal complaint and request immediate legal action and protection for myself and my family due to a serious incident of physical assault and criminal intimidation by my brother-in-law, Chandan Goswami, son of Kailash Goswami, resident of Devdanga Bazar, Champasari, Siliguri.

On 18/07/2025, at around 11:00 PM, my brother-in-law physically assaulted me without any provocation. He slapped me and threatened my family with a knife at our door. We are living in constant fear and emotional distress because of his violent and aggressive behaviour.

Furthermore, we have an audio recording of his mother, Sibi Goswami, where she clearly says:

"Once he comes back, he won't leave you people".

This shows a clear intention to harm us again in the near future, and we fear for our safety.

We kindly request to take actions.
