Sir,

With due respect, I am producing herewith the 05 (Five) arrested accused persons namely (i) Suraj Chhetri (23 Years) S/o-Lt. Sasti Chhetri of Darjeeling more Gas Godown, Po-Pradhannagar, PS- Matigara, Dist- Darjeeling (ii) Raju Rao (28 yrs), S/O- Lt. Bhagat Rao of Dagapur Pancha Nadi, PO+ PS- Pradhannagar, Dist- Darjeeling, (iii) Bikash Roy (21 yrs) S/O- Ramesh Roy of Dagapur, Bandri Jote, PO+ PS- Pradhannagar, Dist- Darjeeling (iv) Satran Mahato (22 years) S/O-Dukha Mahato of Majdur Colony, W/no-28, PS-Siliguri, Dist-Darjeeling, (V) Austin Rai (26 yrs), S/O- Lt. Prem Rai of Darjeeling More, Dagapur, PO+ PS- Pradhannagar, Dist- Darjeeling, and the following articles under seizure :-

1. One iron die measuring approximately 1.5 ft and one Hesco Blade from the possession of accused named Suraj Chhetri.
2. One Iron made L-Khuria measuring approximately 1.5 ft and one torch light from the possession of accused named Raju Rao.
3. One Iron made sabol measuring approximately 2.5 ft from the possession of accused named Bikash Roy.
4. One hammer with handle and one torch light from the possession of Satran Mahato.
5. One Iron made Khuria measuring approximately 1.5 ft and one iron made plus from the possession of Austin Rai.

I, ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 20.07.2025 at 00.30 hrs, received a secret source information that a gang of miscreants were assembled at Matigara Bazar near Hanuman Mandir under PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara Bazar area under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and diarized the matter vide Matigara PS GDE No- 1000, Dated- 20.07.2025. As per your kind order myself along with PSI Avijit Banik, ASI Pema Dorjee Sherpa, C/868 Sujal Roy, C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Matigara Bazar, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 1001, Dated- 20.07.2025. At about 00.40 hrs on 20.07.2025 we arrived at Matigara Bazar under Matigara PS. After arrival at the spot and as identified by the source we found that 10/12 persons were assembled under a tin shed at Matigara Bazar near Hanman Mandir and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 05 (five) persons of them. On interrogation the apprehended accused persons, disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation to commit dacoity at Matigara Bazar area. They also stated that others 05/07 associates were able to fled away from the spot by taking advantages of darkness and rain. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00:50 hrs to 01:15 hrs on 20.07.2025 under proper videography.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Suraj Chhetri (23 Years) S/o-Lt. Sasti Chhetri of Darjeeling more Gas Godown, Po-Pradhannagar, PS- Matigara, Dist- Darjeeling (ii) Raju Rao (28 yrs), S/O- Lt. Bhagat Rao of Dagapur Pancha Nadi, PO+ PS- Pradhannagar, Dist- Darjeeling, (iii) Bikash Roy (21 yrs) S/O- Ramesh Roy of Dagapur, Bandri Jote, PO+ PS- Pradhannagar, Dist- Darjeeling (iv) Satran Mahato (22 years) S/O-Dukha Mahato of Majdur Colony, W/no-28, PS-Siliguri, Dist-Darjeeling, (V) Austin Rai (26 yrs), S/O- Lt. Prem Rai of Darjeeling More, Dagapur, PO+ PS- Pradhannagar, Dist- Darjeeling, and others and arrange for its investigation.
