I Sakshina Begam, the above noted complainant
beg to inform you that on St. 17.07.2025 at about
09:00 am, when my daughter namely, Razina Khatun
(08 yrs) D/o Md. Nazrul Islam, was playing in front
of my rented house at Adarshanagar Colony, Ward No. 4
at that time, one Md. Nasim S/o 4. Md. Murtuza,
slapped my said daughter and she started crying,
and when I asked him that why he slapped
my child, then he started abusing me in filthy
languages and when I protested, he attacked
me with sharp iron scissor (clothe etc. cutting sharp
instrument) with intention to kill me.

I received grievous chest injury and heavy
bleeding started coming from there and I was
immediately shifted to Siliguri Distt. Hospital
and admitted there on St. 17-07-2025 morning.
