on the night of 17-07-25 at mid night no was present at the house. Some unknown miscreants broke into my house by entering through the terrace, shockingly they left their weapons (an axe and one hammer) I found my entire house vandalized. The door knobs of each room were broken and damaged. All my belongs were thrown out of the Almirahs and scatters across the house. I received on 19/07/25 at 20:10 hrs vide DE NO-1121 and started Bhaktinagar AS case NO-75/25 dated-19/07/25 vide OS BNS, 2023 and indexed to ASI Kragon Boman for its investigation.
