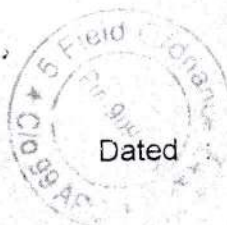

FIR FOR TRESPASSING IN A RESTRICTED MILITARY AREA

1. This is to bring to your attention about an incident of trespassing which occurred on 20 Jul 2025 at around 0030 hrs within the high-security premises of 5 FOD Technical Area, near Guard Post No 14.
