Respected Sir,

With due respect I Smt. Priya Sarkar, Wife of Sri Aurobinda Sarkar, residing at Janata Nagar, PO Sevoke Road, PS Bhaktinagar, Dist. Jalpaiguri, would like to lodge a complaint regarding a serious incident of physical assault and life-threatening behavior against me and my mother namely Smt. Baby Sari Sawal.

There is a person in the locality of my mother at TB Hospital Quarter, Sevoke Road, PS Bhaktinagar namely Bicky Mallick, who is involved in the illegal sale of narcotic injections and addictive drugs. My mother had recently objected to his activities, requested him to stop such illegal dealings and for that today at about 12:30 p.m the said person along with his wife namely Sonia Mallick came to my paternal house and brutally assaulted my mother by fist and blow. They both used abusive languages and beat my mother with the intent to seriously injure or possibly kill her.

When I rushed to the spot to protect my mother, the man physically attacked me as well. He held me by the throat and choked me to the point where I couldn't breathe properly for a while. There are visible injury marks on my neck caused by his assault and he also used to criminal force to outrage my modesty.

Both my mother and I are traumatized and in physical pain due to this unprovoked and violent attack. We fear for our safety as these individuals have shown clear intent to harm us further.

Thereafter I along with my mother went to the Siliguri Hospital with a help of local people and treated there.

Therefore, I request you to kindly register this complaint as an FIR under appropriate sections and Please take immediate and strict legal action against the accused and ensure the safety and protection of my family.
