I, I would draw your kind attention towards the fact that I am the manager of a hotel cum resort namely "Viramma Resort", situated at Hill Cart Road, Dagapur,

That today i.e., on 20.07.2025 one of my employee/staff member, namely Prasanjeet Das, son of Dilip Das, permanent resident of House No. 37, Arya Vidyapeeth College Sharabhathi, Guwahati, Gopinath Nagar, Kamrup (Metro), Asaam, Pin Code - 781016, mobile nos. 7002411680 and 7407501775 has stolen our official mobile phone having model name Motorola XT 2523-9 MotoG 05, 64gb, Plum Red Color, having IMEI 1 No. 353992432222496 and IMEI 2 no. 353992432222504 and mobile no. 74776-96999 from the restaurant along with cash amounting to Rs. 10,000/- (Rupees Ten Thousand only).

The incident came to my notice today at about 8:30pm, when I discovered both the mobile phone and the cash are missing from the cashbox. Upon checking our internal records and speaking with other staff members, it came our knowledge that the aforementioned accused person was last seen in the area where the cashbox is situated.
