Subject: General Diary Entry Regarding Deliberate Damage of Electric Meter, Theft of Electrical Wiring, and Suspicious Activity at Under-Construction Residential Property

Respected Sir,

I, Anurag Lama, son of Shri Bikash Lama, a resident of Khwaish Residency, Tea Auction Road, Mallaguri, Siliguri, District Darjeeling, PIN 734003, am writing to formally lodge a General Diary (GD) entry in respect of a serious and disturbing incident that occurred at our under-construction residential building located at DM Road, Middle Palash, Devidanga, Champasari, Siliguri.

On 20th July 2025 in the evening, I was informed by our building's caretaker that the electrical lights within the premises were not functioning. Upon receiving this information, we immediately instructed him to inspect the electric meter box and conduct a basic check. To our alarm, he found that the wiring had been deliberately and professionally tampered with. Both the live and neutral wires coming out of the meter box had been sliced, resulting in a complete disconnection of power supply to the building. Additionally, the electrical wires that powered the light fixture near the front gate had been forcibly removed and taken away. Interestingly, the bulb itself was left intact, which reinforces the theory that the objective was not petty theft, but to disable surveillance or lighting for a larger premeditated purpose.

The property is currently in the final stages of construction and is not yet occupied. However, it stores various government-issued service assets and personal belongings belonging to my father, Shri Bikash Lama, who is presently serving as the Additional District Judge, posted at the Kalimpong District Court. These items, which include confidential documents, appliances, furnishings, and government property provided to him in his official capacity, are stored securely at the premises until final relocation. Given this context, the incident raises serious apprehensions of a possible reconnaissance or preparatory act with the intention to unlawfully access or misappropriate those items.

In response to the caretaker's report, we conducted a review of CCTV footage from neighboring buildings. At approximately 3:02 PM on 20/07/2025, three unidentified individuals were seen moving suspiciously around the vicinity of the property. Their behaviour suggests they were either surveilling the premises or attempting to identify vulnerabilities. Their movements were not consistent with those of local pedestrians or workers in the area.

It must be pointed out that this is not the first time such an incident has taken place at this property. A similar event involving tampering with electrical infrastructure occurred earlier, though on that occasion, it appeared minor and was presumed to be an isolated act of vandalism. However, the recurrence of such conduct, this time accompanied by targeted interference with electrical security, strongly indicates a pattern and possibly a larger conspiracy.

This matter cannot be treated lightly. The disconnection of electricity and the removal of wiring, particularly around a construction site housing government-issued assets, has wider implications. This appears to be an attempt to render the premises vulnerable to further trespass or theft. Given

the status of my father as a member of Higher Judicial Service (District Judge Entry level) and the presence of official government property at the site, this incident raises serious questions about motive, timing, and intent.

Accordingly, I urge your office to treat this matter with the seriousness it deserves and take immediate steps to initiate a formal investigation. I request that a site visit be conducted at the earliest convenience, and efforts be made to collect and preserve CCTV footage from the surrounding area for forensic review and to nab the culprits. The possibility of this being a planned and coordinated attempt to breach property housing government properties cannot be ruled out.
