Subject: Request for registration of FIR against Kamal Lama for illegal sale of ancestral tribal property

Respected Sir,

I, Mrs. Pema Lamu Tamang @ Guddu, daughter of Late Surjya Kumar Tamang@ Suraj Kumar Tamang and Late Deo Kumari Barua, and wife of Mr. D.B. Chettri, presently residing at Anugrah Mahima Church, Ward No. 43, Gandhi Nagar, Siliguri, most respectfully submit this complaint for your urgent attention and necessary legal action:

- 1. That I am the biological daughter of Late Surjya Kumar Tamang, who belonged to the Scheduled Tribe (ST) community of West Bengal.
- 2. That the accused, Mr. Kamal Lama, is my stepbrother, being the son of my stepmother, originally named Geeta Pradhan, who later became Geeta Tamang after marrying my father.
- 3. That my father, Late Surjya Kumar Tamang @ Suraj Kumar Tamang, owned a landed property measuring 10 decimals, situated at Mouza Siliguri, under Khatian No. 429/1, R.S. Plot No. 332, L.R. Plot No. 4781, R.S. J.L. No. 110(88), L.R. J.L. No. 89, Ward No. 3, P.S. Pradhan Nagar, District Darjeeling.
- 4. That my father passed away on 21.03.1986, and my mother, Late Deo Kumari Barua, passed away earlier on 01.06.2016 and my step mother Geeta Pradhan @ Tamang died on 07.06.2016.
- 5. That I recently came to know that a Deed of Gift was illegally executed by my stepmother, Geeta Tamang (originally Geeta Pradhan), in favour of her son, Kamal Lama, on 21.09.2011, without my knowledge and behind our back without the consent and knowledge of my mother and myself. Shockingly, I only discovered

the existence of this deed in 2024, and my father was not a signatory to the same, despite being the recorded owner of the land.

- 6. That thereafter, on 16.03.2023, Mr. Kamal Lama, without any legal authority or my knowledge or consent, sold the said entire property to one Badal Chandra Saha, son of Late Santosh Kumar Saha, residing at 2/D Daffodil Hill View Residency, Ward No. 42, Bhaktinagar, P.S. Bhaktinagar, District Jalpaiguri.
- 7. That I am a 50% rightful co-sharer of the said property by inheritance, and no partition has taken place till date. The said sale has been made behind my back, by suppressing facts and without any authority or legal title, thereby depriving me of my rightful tribal property.
  - 8. That the said transaction was further enabled by a fraudulently obtained permission from the Revenue Officer, allowing the sale of a tribal land to a non-tribal buyer, in gross violation of the protections under the West Bengal Land Reforms Act and other ST protective legislations.
- 9. That I strongly question how such permission could have been granted by the Revenue Officer, when it is legally barred to transfer tribal land to a non-tribal without following the strict statutory procedure and conditions, none of which were fulfilled in the present case.
- 10. That the entire act has been carried out with fraudulent intention and malafide design to deprive me of my ancestral rights and to defeat the protective laws meant for Scheduled Tribe persons.
- 11. That prior to filing this complaint, I had already submitted a written representation to the Commissioner of Police, Siliguri, but no effective action has been taken till date.

In view of the above grave and unlawful acts, I most respectfully request you to:

a. Register an FIR against Mr. Kamal Lama and all other persons involved under relevant sections of the Indian Penal Code and the West Bengal ST Land Protection laws,

- b. Investigate the illegal sale and fraudulently obtained permission,
- c. Ensure protection of my share in the property, and
- d. Take appropriate legal action to bring the culprits to justice.
  I shall remain ever grateful for your urgent and fair intervention.
