In producing herewith three (05) accused persons namely (i) Rajiv Sewa (45yrs) S/O Mani Kumar Sewa of Church road, upper Arithang, Gangtok, PS Sadar, Dist East Sikkim, (ii) Shiv Kumar Sha (40yrs) S/O Ratan Sha of Adarsh nagar, Jhankar more, PS Siliguri, Darjeeling, (iii) Dilip Biswakarma (44yrs) S/O Lt. Balram Biswakarma of Gurung Busty, W/no. 03, PS Pradhannagar, Darjeeling, (iv) Pankaj Singh (28yrs) S/O Lt. Ramashis Singh of Gurung Busty W/No. 03, PS Pradhannagar, Darjeeling (v) Deepjay Tamang (25yrs) S/O Deep Kumar Tamang of Ale Dhura, Ghum, PS Jorbonglow, Darjeeling, under arrest along with the following seizure articles viz:- (i) One sharp cutting weapon locally called as "Hasua" measuring approx approx 22 inches in length including its wooden handle (ii) One iron rod approx measuring 24 inchs in length, (iii) One iron made "Hammar" including its iron butt, (iv) One iron made sharp cutting weapon locally called as "Bhojali" approx measuring 16 inches in length including its wooden hendal, (v) One iron made "Sabol" measuring approx 16 inches in length, (vi) One iron made shap one edged sword approx measuring 30 inchs in length with iron handle, (vii) One iron made "Plush", (vii) one multicolor nylon carry bag.

I SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted five (05) arrested accused persons and others 06/07 unknown miscreants who involve in this crime to the effect that on 23.07.2025 at 00.15 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled in at Champasari more, near vegitable market, under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Bagajatin Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vides Pradhan Nagar PS GDE No. 1410 dated 23.07.2025 and informed the matter to you. As per your kind order and direction I accompanied SI Bandhan Roy, SI Goutam Mallik, ASI Biplab Kumar Das and force all of Pradhan Nagar PS, SPC left for Champasari More under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information, vide Pradhannagar PS GDE No. 1411 dated 23.07.2025, without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I informed night van officer ASI Sanjib Mukherjee of Pradhan Nagar PS and directed him to come at Champasari more, near vegitable market, under PS- Pradhan Nagar, Dist. Darjeeling to accompany us. At around 00.30 hrs we reached Champasari more, near vegitable market, under PS- Pradhan Nagar, Dist. Darjeeling in the meantime R.T. van officer ASI Sanjib Mukherjee arrived there and accompanied us. I shared the information with them and briefed them properly. Then, I requested two available independent witnesses namely (i) Arun Sahani (25 yrs), S/O Upendar Sahani and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani both of Reajendra Nagar, Coolipara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance we noticed that some persons were assembled at vegitable market, situated at Champasari more, under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching them they tried to flee away from the spot but on hot chase we managed to apprehended above noted five (05) accused persons while 06/07 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside a multi colour nylon carry bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at Bagajatin Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 00:45 hrs to 01.40 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with 06/07 of their associates who fled away gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Bagajatin Colony.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted five (05) arrested accused persons namely (i) Rajiv Sewa (45yrs) S/O Mani Kumar Sewa of Church road, upper Arithang, Gangtok, PS Sadar, Dist East Sikkim, (ii) Shiv Kumar Sha (40yrs) S/O Ratan Sha of Adarsh nagar, Jhankar more, PS Siliguri, Darjeeling, (iii) Dilip Biswakarma (44yrs) S/O Lt. Balram Biswakarma of Gurung Busty, W/no. 03, PS Pradhannagar, Darjeeling, (iv) Pankaj Singh (28yrs) S/O Lt. Ramashis Singh of Gurung Busty W/No. 03, PS Pradhannagar, Darjeeling (v) Deepjay Tamang (25yrs) S/O Deep Kumar Tamang of Ale Dhura, Ghum, PS Jorbonglow, Darjeeling, and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.
