Sir,

With due respect I Anita Sah wife of Subodh Sah aged around 55 yrs, resident of Kulipara, near cremation Ghat, Ward No. 1, P. O. and P.S. Pradhan Nagar want to state the fact that the illegal wine distributor and seller Chandeswar Paswan along with his wife Sushila Paswan and other family members Narshim Paswan, Chhotu Paswan, Babita Paswan and Bhukhali Paswan resident of same locality has bitten with rod and other ~~gun~~^{weapon} to my son Rahul Sah and Sunny Sah so badly that they get head injury and other injury. Not only that they have also physically assault and abused my daughter Soni Kumari Sah by using filthy language. The medical report of my sons is attached with this application for your kind perusal.

The reason of the quarrel is that the wine seller, Chandeswar Paswan who was selling alcohol on the road, come in argument with my son on the way while my son Rahul Sah went to cremate one of my near and dear. He also put threat to us that he has fixed the Pradhan Nagar Police Station on monthly basis for his illegal business of selling wine. Therefore the Pradhan Nagar P.S. will not take any action against him. He further threatens me that if I go to Pradhan Nagar Police Station to lodge complain against them then I have to suffer with dire consequences.

Therefore, I would request you to register my complain and take necessary actions against the above mentioned persons.
