Sir,

With due respect, I ASI Amit Sarkar s/o Late Haripada Sarkar of Ashighar Out Post under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the following person to deter me as on duty police officer to my schedule Government duty on 22.07.25 at around 15.25 hrs at Italian Math Netaji Pally Ward No- 37 under PS, Bhaktinagar.

The facts of the case in brief are that on 21.07.25 over the written complaint lodge by one Smt. Geeta Saha (Mob. No. 8927715623) W/O Lt. Manoj Saha of Arabinda Pally, Italian Math, PO- Ghoghomli, Siliguri that on 20.07.2025 at around 23.30 hrs she came to learn that her Minor granddaughter Guriya Dey (16 yrs) D/O Lt. Bidhan Dey has been allegedly kidnapped by one Anup Mallick S/O Nitai Mallick of Arabinda Pally, Italy Math, PO- Ghoghomli. This refers Bhaktinagar PS, Case No. 718/25, Dated: 21.07.2025, U/S- 137(2)/140(3) BNS, 2023 has been registered IO. SI Khela Murmu.

During investigation on 22.07.25 at afternoon around 15.15 hrs, as per reliable source information, I ASI Amit Sarkar along with investigation officer SI Khela Murmu and the parents of minor girl attended at Italian Math, Netaji Pally Ward No- 37 under PS, Bhaktinagar to recover the minor VG, and at the time one later known as Jit Barui restrained the VG, and obstructed me. On asking he threaten and challenge me also restrained police team to performing my schedule Govt. duty.

Under the above facts and circumstances, I pray before your kind honor that a specific case against the abovementioned Sri Jit Roy under proper section of law and request to arrange its investigation.
