In producing herewith three arrested accused person namely Pritam Hela (M/21 yrs) S/O Late Demu Hela of Lichubanag, Subhashpally, Ward No. 18, PS-Siliguri, Dist- Darjeeling and the following seized articles viz.

a) One Multiple colours of Plastic Sac (bag) containing sealed 30 (thirty) bottles of Cough Syrup (Codein Phosphate & Triprolidine Hydrochloride Syrup) containing 100 ml each having batch no. 011123SD83 and expiry date:-OCT2025 and marked as 'Exhibit- A'
b) One Multiple colours of Plastic Sac (bag) and marked as Exhibits-B,

[Articles noted in Sl. No. (a) & (b) was seized from the exclusive and conscious possession of the above noted arrested accused person who was holding said Multiple colours of Plastic Sac (bag) in his hand],

I, SI Biplab Barman of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted Pritam Hela (M/21 yrs) S/O Late Demu Hela of Lichubanag, Subhashpally, Ward No. 18, PS- Siliguri, Dist-Darjeeling (Not verified) to the effect that today on 25.07.2025 at about 16.05 hrs received a specific source information that one person was standing with huge quantity of Contraband Cough syrup at P & T Goli, Milanpally, Ward No. 25 under Siliguri to sell the same to his designed customers for his wrongful gain. The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No.1532 Dated-25.07.2025 and subsequently, I informed the matter to the Inspector-in-Charge, Siliguri Police Station in written and being directed, myself along with SI Biswadeb Barman, ASI Subir Scn, ASI Debasish Das, ASI Rabin Lama, Const-160 Soumen Sarkar all of Siliguri PS, SPC and along with investigation kit left for P & T Goli, Milapally, Ward No. 25 under Siliguri PS by Govt. aided vehicle having Registration No-WB24K/7669, driven by CD-1148 Sudipta Nandi to verify the veracity of the source information. This refers to Siliguri PS GDE No.1533 Dated- 25.07.2025 and M.C.C No-694/2025 Date-14.05.2025. I also informed cameraman namely Ganesh Paswan (52 yrs) S/O Natthu Paswan of Swami Vivekananda Road near Madrasa School, Khalpara ,Ward No. 08, P.S- Siliguri, Dist.- Darjeeling. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to P & T Goli, Milanpally under Siliguri Police Station, I contacted two persons namely (1)Sahensaha Alam (M/29 yrs) S/O Late Rahamatulla Prodhan of Shaktigarh, Road No. 06, Ward No. 31, PS- NJP, Dist-Jalpaiguri (9239397796) and (2) Hemant Chowdhury (M/25 yrs) S/O Guddu Chowdhury of Jalpaimore, Natupara, Ward No. 05, PS- Siliguri, Dist- Darjeeling (7797646245) and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at P & T Goli, Milanpally under PS Siliguri, Dist-Darjeeling at 16.25 hrs and being pointed by the source able to apprehend the above noted person who was holding above noted Multiple colours of Sac (bag) at P

& T Goli, Milanpally under PS Siligurl, Dist. Darjeeling. Thereafter, we disclosed our identity and informed him regarding the information in hand and stated him that he will be searched in person for the said purpose. It is also found that the above noted apprehended person was covered with bandage in his left hand as he was injured previously.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained person was carrying contraband cough syrup in his exclusive possession & trying to supplying/ selling the same in the area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he have illegally possessed contraband cough syrup without any valid license for selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazzetted cofficer and he agreed to be searched in presence of any one of them. In the above mentioned time, there are scare chance to contact any Executive Magistrate. No other alternative way, I informed the fact to Shri Prasenjit Biswas, Inspector—into other alternative way, I informed the fact to Shri Prasenjit Biswas, Inspector—the accused person suspected to be possessed contraband cough syrup and requested the accused person suspected to be possessed contraband cough syrup and requested him to come at P & T Goli, Milanpally, Ward No. 25 under Siliguri PS to remain present and to supervise the search and seizure as Gazetted Officer.

Accordingly, at 16.55 hrs Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived in full uniform at the spot i.e p & T Goli, Milanpally Ward No. 25 under Siliguri PS and introduced himself as Gazetted Officer. Then, I offered the independent witnesses and the accused person to search our police party as per provision of law but he did not search the police party but as per supervision of Shri Prasenjit Biswas, Inspector -in-the police party but as per supervision of Shri Prasenjit Biswas, Inspector -incharge, Siliguri Police Station acting as Gazetted Officer personal search of our charge, Siliguri Police Station acting as conducted but nothing incriminating was raiding party and our vehicles was conducted but nothing incriminating found. A nil search list to that effect was prepared in-between 17.05 hrs and

Thereafter in presence Shri Prasenjit Blswas, Inspector –in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained person following all formalities, keeping his decency and recovered a) One Multiple colours of Plastic Sac (bag) containing sealed 30 (thirty) bottles of a) One Multiple colours of Plastic Sac (bag) containing Syrup (Codein Phosphate & Triprolidine Hydrochloride Syrup) containing Cough Syrup (Codein Phosphate & Triprolidine Hydrochloride Syrup) and 100 ml each having batch no. 011123SD83 and expiry date:-OCT2025 and marked as 'Exhibit-'A', b) One Multiple colours of Plastic Sac (bag) and marked marked as 'Exhibit-'A', b) One Multiple colours of Shri Prasenjit Biswas, as Exhibits-'B'. Further, on demand in presence of Shri Prasenjit Biswas, as Exhibits-'B'. Further, on demand in acting as Gazetted Officer as well as Inspector –in-charge, Siliguri Police Station acting as Gazetted to produce any valid documents in support of possessing of such contraband.

Being further interrogation, all the above noted accused person admitted in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that he have procured the above noted illegal contraband cough syrup clandestinely for the purpose of selling the same in high rate to their designed customers for his personal gain by illegal means. The above noted accused person also disclosed that he have been dealing in this business of procuring and selling of contraband cough syrup illegally for last few months for his wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted accused person at the spot at P & T Goli, Ward No. 25 under Siliguri Police Station Dist- Darjeeling under proper seizure

list in presence of Shri Prasenjit, Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labelled the seized articles in presence of Shri Prasenjit Biswas Inspector is above. Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer and independent of seizure and label independent witnesses as noted above. The whole process of seizure and label was made in between 17.25 hards 18.25 and 19.25. The whole process of was made in between 17.35 hrs to 18.15 hrs on 25.07.2025. The whole process of Search seizure is seen 17.35 hrs to 18.15 hrs on 25.07.2025. Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the above noted accused person namely Pritam Hela (M/21 yrs) S/O Late Demu Hela of Lichubanag, Subhashpally, Ward No. 18, PS- Siliguri, Dist-Darjeeling (Not verified) is involved in procuring and selling of contraband cough syrup illegally contravening the norms of NDPS Act. Then, I arrested the above noted account. noted accused person after observing all the formalities and informing the ground of his arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons Pritam Hela (M/21 yrs) S/O Late Demu Hela of Lichubanag, Subhashpally, Ward No. 18, PS- Siliguri, Dist- Darjeeling (Not verified) and arrange for its investigation.
