In producing herewith one arrested accused person namely Debendra Kumar (40) S/O Lt. Bishnu Deb Singh of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles as per proper seizure list:

1. Total 05 (five) bottles of Himalayan Gold 60 UP Country Spirit, each bottle containing 600 ml, total 3000 ml. / 3 L.
2. Total 03 (three) bottles of Kachi 70 UP Country Spirit, each bottle containing 300 ml, total 900 ml / 0.9 L.

I, ASI Subhash Roy of Khalpara TOP under Siliguri Police Station do here by lodged a written complaint against the above noted accused person named Debendra Kumar (40) S/O Lt. Bishnu Deb Singh of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling to the effect that today on 25.07.2025 at 20.45 hrs. I received a credible source information that one person is selling huge quantity of liquor/ alcohol at Jyotinagar colony under 4th no. Mahananda Bridge, Ward No. 04 of SMC under Siliguri Police Station in higher price than the actual value for his wrongful gain without any documents/license. Subsequently, after sharing the information with my superiors and as per their direction, myself along with force of Khalpara TOP left for the place to work out the information. The fact was diarized in Khalpara TOP-II under Siliguri Police Station GDE No- 805 Dated-25.07.2025.

After we reached at the spot at 21.05 hrs. and on being identified by the source our police party held raid Jyotinagar Colony under 4th no. Mahananda Bridge under Siliguri Police Station and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the liquor/ alcohol in open market at Jyotinagar colony area since long for his wrongful gain without any valid documents/license. Accordingly, I seized the above noted articles from his possession after preparing proper seizure list and arrested him after maintain all formalities in presence of witnesses. The seizure was made on 25.07.2025 in between 21.30 hrs. to 21.55 hrs. under videography.

Under the above circumstances, I request you to start a specific case may kindly be started against the accused person namely Debendra Kumar (40) S/O Lt. Bishnu Deb Singh of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling under proper section of law and arrange for investigation.
