Subsequently, after sharing the information with my superiors and as per their direction, myself along with force of Khalpara TOP left for the place to work out the information. The fact was diarized in Khalpara TOP-II under Siliguri Police Station GDE No- 805 Dated-25.07.2025.

After we reached at the spot at 21.05 hrs. and on being identified by the source our police party held raid Jyotinagar Colony under 4th no. Mahananda Bridge under Siliguri Police Station and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the liquor/ alcohol in open market at Jyotinagar colony area since long for his wrongful gain without any valid documents/license. Accordingly, I seized the above noted articles from his possession after preparing proper seizure list and arrested him after maintain all formalities in presence of witnesses. The seizure was made on 25.07.2025 in between 21.30 hrs. to 21.55 hrs. under videography.

Under the above circumstances, I request you to start a specific case may kindly be started against the accused person namely Debendra Kumar (40) S/O Lt.
