Sir,

In producing herewith one arrested accused person namely Sri Shakti Barman (M-29yrs) s/o BImal Barman of Nimtala Kali Mandir near Jaleswari Bazar PO, Sahudangi hat PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

[1] 13 (Thirteen) sealed bottles of "HIMALAYAN GOLD" 60 UP PET India Made Liquor each bottle containing 600 ml, i.e. 600 X 13 = 7800 ml, having M.R.P. of Rs. 160/- i.e. 160 X 13 = Rs, 2080/-, bottled by Himalayan Endeavour Pvt. Ltd and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, ASI Dinesh Ch Roy S/O Late Madhu Roy of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Sri Shakti Barman (M-29yrs) s/o Bimal Barman of Nimtala Kali Mandir near Jaleswari Bazar PO, Sahudangi hat PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that on 25.07.25 at around 13.25 hrs. I received a reliable source information that one person is selling illicit liquor in his house at Jaleswari bazar under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 875 Dated 25.07.25, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force left for Jaleswari bazar to verify the veracity of the information vide GDE NO 876 dtd, 25.07.25. At around 13.30 hrs on reaching there and as identified by the source we cordon the house and held raid and apprehended one on being asked he disclosed his identity as noted above also stated that he is selling illicit liquor from his house without any valid license for his wrongful gain during raid some customers are managed to flee away from the spot. On further search, the above-noted seized articles were recovered from his house. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, Shakti Ghosh stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested Shakti Ghosh u/s 35 BNSS 2023 after observing all sorts of formalities at the spot to maintain her modesty also inform her ground of arrest. The whole process of seizure and label has been made in between 13.34 hrs to 13.44 hrs the whole process of search and seizure under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Sri Shakti Barman (M-29yrs) s/o BImal Barman of Nimtala Kali Mandirnear Jaleswari Bazar PO, Sahudangi hat PS- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
