Sir,

In producing herewith one arrested accused person namely Aman Rai (31 yrs) S/o Ganga Kumar Rai of Raj Papri, Near B.S.F Gate, PS- Bhakti Nagar, Dist- Jalpaiguri along with the following articles under proper seizure list: -

- [1] Fifteen (15) bottles of Himalayan Gold 60 UP country spirit (each bottle containing 600 ml.)
- [2] One multi colour nylon bag.

I. ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above-noted arrested accused person namely Aman Rai to the effect that today on 25/07/25 at 20.05 hrs, I received source information that one person is selling illicit liquor at Salugara Bazar under Bhaktinagar PS, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Bhakti Nagar PS GDE No.1640 Dated 25/07/25 and shared the information to IC Bhakti Nagar PS. As per his kind direction, I along with force left for Salugara Bazar under Bhaktinagar PS, Dist. Jalpaiguri to verify the veracity of source information in hand. We reached there as identified by the source we held a raid at Salugara Bazar and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he has is selling the same without any valid license for his wrongful gain. On further search, the above-noted seized articles were recovered from his possession. On-demand he failed to produce any valid license/papers for selling such articles. On further interrogation, he stated that he had been involved in selling illicit liquor without any valid license for the last few months for his illegal gain. Then, I seized the above-mentioned liquor under the proper seizure list and arrested the person mentioned above after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 21.05 hrs. to 21.40 hrs under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Aman Rai (31 yrs) S/o Ganga Kumar Rai of Raj Papri, Near B.S.F Gate, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
