Sir,

In producing herewith one arrested person namely Biltu Sarkar @ Subho (33 years) S/O Lt Sreekantha Sarkar of Dabgram Madhya Santinagar, pipeline PS Bhaktinagar, Dist Jalpaiguri along with the following seized articles under seizure as per seizure list:

- (i) One blue colour bag pack with Nike logo containing 30 (thirty) bottles of Chlorpheniramine maleate & Codeine Phosphate syrup "R-Kuff plus" having batch number TBHW0178 mfg dated 02/2023, Exp date 01/2025, each bottle containing 100 ML, marked as exhibit 'A'
- (ii) One Yamaha R15 motorcycle red & white colour with registration no WB 74 AR 6241 marked as Exhibit "B"
- (iii) One vivo V21e 5g mobile having IMEI no 86395053743574 connecting sim number 9851080704, 9144669655 marked as exhibit "C"

I, SI Youel Iepcha S/O Jai Tshering Lepcha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 25.07.2025 at about 19.40hrs, received a reliable source input that one person is believed to be in possession of a large quantity of narcotic substance on a Yamaha R15 Motor cycle, having registration no WB 74 AR 6241 Coming from eastern bypass ashigarh area under Bhaktinagar PS. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 1637/25 dated 25.07.2025 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 19.55hrs I along with ASI Dhurbo Mishra, ASI Dipak Karmakar and Const/374 Debraj Biswas left PS by govt. hired vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE no. 1638/25 dated 25.07.2025 and M.C.C No- 3737 /25 dated 25.07.2025

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On the way to Eastern bypass as per order of IC PS I called k 38 patrol van officer SI Sajhan Ali, C/ 843 Suman Basfore and C/977 Enamul Haque Sarkar for accompany us to work out the information.

Thereafter at about 20.35hrs we reached at eastern bypass near modal petrol pump and after arriving there I found the public there at the spot and I tried to convince them to accompany us. The following persons namely 1) Shambu Roy (26 year) S/O Ravi Roy of Baikuntha pally behind Mondal petrol pump, w/N 41, PS Bhaktinagar, Dist Jalpaiguri, 2) Uttam Roy (27 years) S/O Lt Khatkia Roy of Baikuntha pally behind Mondal petrol pump, w/N 41, PS Bhaktinagar, Dist Jalpaiguri came forward to accompany us to work out the information.

Thereafter I informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being indicated by source we detained one red and white colour motor cycle having registration no WB 74 AR 6241 one person who was carrying bag pack and we disclosed our identity and the information in hand and stated him that he will be searched in persons for the purpose. At this, he disclosing his name and address as noted above. Further he confessed that he has possessed the illegal syrup for supplying the same to his designed customers as per requirement. I then gave him option whether he wanted to be searched in presence of the special Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched by one of them. Further I served a notice in accordance with provisions of law in this regards.

I sent a written requisition to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station to come at eastern bypass near modal petrol pump Baikunthapally under Bhaktinagar PS, requested him to present for supervising search and seizure.

At 21.45hrs Shri Amit Adhikay, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision and in presence of witnesses the process of search of the detained person was conducted and recovered the above noted articles.

Subsequently, being demanded in presence of Shri Amit Adhikary Inspector In-Charge, Gazette Police Officer the detained person failed to produce any valid document in support of aforesaid recovered syrup.

I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses, I also labeled and sealed the same, the entire search and Seizure was conducted under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS. The whole process of search & seizure has been captured in audio & VDO graphed. The whole process of seizure was made in between 25.07.2025 in between 22.00hrs to 23.05hrs

Being further asked, the apprehend person admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the syrups clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for personal gain by illegal means also disclosed that he has been dealing in such business of procuring and selling of syrups illegally for last few months.

Then, I arrested the above noted accused person namely Biltu Sarkar @ Subho (33 years) S/O It Sreekanta Sarkar of Dabgram Madhya Santinagar, pipeline PS Bhaktinagar, Dist Jalpaiguri after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Biltu Sarkar @ Subho (33 years) S/O It Sreekanta Sarkar of Dabgram Madhya Santinagar, pipeline PS Bhaktinagar, Dist Jalpaiguri and arrange for its investigation.
