Sir,

With due respect, I am producing herewith 01(one) arrested accused person  
Dipankar Debnath (27 yrs approx), S/O- Prasanta Debnath of Shivmandir, Halpuria, Kharak  
Singh Road, PO- New Rangia, PS- Matigara, Dist- Darjeeling under arrest and the following  
article under seizure :-

1] 01 (One) fire arm (one shutter) black in colour measuring Approx 48 cm in length from barrel  
to butt and including its 32 cm barrel with one trigger, striking hammer, striking pin in working  
condition Marked as "Exhibit-"A"

I, ASI Pema Dorjee Sherpa of Matigara PS, SPC do hereby lodge this written complaint  
against the above noted arrested accused person. In this regard, I beg to report that today i.e. on  
25.07.2025 at around 15:25 hrs, I received a secret information that one person with fire arms  
waiting at Slab factory near Deonia More under Matigara PS jurisdiction to deliver the same to  
his designated customer. This refers to Matigara PS GDE No- 1330, Dt- 25.07.2025.  
Accordingly, I informed the matter to you and as per your direction, myself along with ASI  
Bikash Roy, ASI Chandra Prakash Adhikary, C/523 Sanjit Kundu, C/868 Sujal Roy and C/219  
Sanatan Chitrakar all are of Matigara PS, SPC left for slab factory near Deonia More under  
Matigara PS with investigation kit to work out the information in hand by Govt. vehicle. This  
refers to Matigara PS GDE No- 1331 dated 25.07.2025 and vide MCC no. 2304 dated  
25.07.2025. We reached at the spot i.e. at the Slab factory near Deonia More under Matigara PS  
at about 15:55 hrs. At about 16:10 hrs, as indicated by the source we were able to find out one  
person inside an abandoned broken room at the slab factory and was able to apprehend him. On  
being asked he disclosed his identity as noted above. As per source information, that he was  
possessed fire arm. Hence, immediately I searched the above noted person and found 01 (One)  
fire arm (one shutter) black in colour measuring Approx 48 cm in length from barrel to butt and  
including its 32 cm barrel with one trigger, striking hammer, striking pin in working condition  
from the possession of the above noted detained person which was kept in hidden condition at  
the back side of his waist. He exclusively possessed fire arm illegally. On demand he failed to  
produce any document in support of the said fire arm which has been found from his possession.  
On further interrogation he stated that he brought the fire arm from Panitanki and waiting for his  
designated customer to deliver the same for his wrongful gain. Thus when his involvement in  
carrying and possessing illegal fire arm was established, I seized that fire arm under proper  
seizure list duly signed by him as well as by available witnesses. Then I, arrested the  
apprehended accused person after issuing memo of arrest informing him about the ground of  
arrest. The whole processes of search, seizure, label and arrest was made in between 16:17 hrs to  
16:40 hrs on 25.07.2025.



Under the above noted facts and seizure of incriminating article, there is strong reason to believe that the accused person namely Dipankar Debnath (27 yrs approx), S/O- Prasanta Debnath of Shivmandir Haler Matha, Kharak Singh Road, PO- New Rangia, PS- Matigara, Dist- Darjeeling is desperate and dangerous in nature, as he was carrying the said fire arm for self purpose.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Dipankar Debnath (27 yrs approx), S/O Prasanta Debnath of Shivmandir Haler Matha, Kharak Singh Road, PO- New Rangia, PS- Matigara, Dist- Darjeeling under appropriate section of law and arrange for its investigation.
