In producing herewith three arrested accused persons namely 1 Kalpana Biswas (F/50) W/O- Shyamal Biswas, of Kalam Jote near Shantiniketan Apartment, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling, (2) Archana Barman (35), w/o – Bimal Barman, of Kalam Jote near Shantiniketan Apartment, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling & (3) Madhabi Biswas, w/o – Ujjal Biswas, of - Kalam Jote near Shantiniketan Apartment, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling.

I SI Sanjit Das of NBMC OP under Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three (03) arrested accused persons and (1) Bimal Barman, s/o - Bishatu Barman, (2) Ujjal Biswas s/o -Shyamal Biswas (3) Bikram Barman, s/o - Bishatu Barman all are resident of Kalam Jote near Shantiniketan Apartment, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling to the effect that on 25.07.2025 at 14.40 hrs I along with ASI Bhanu Pradhan, C/500 Mayaram Oraon, C/1085 Mithun Debnath, LC 271 Basabi Barman & LC 398 Ratna Roy left for perform special drive duty under NBMC OP area vide NBMC OP GDE No-896 dated-25.07.2025 and MCC No-1298, Dated 25.07.2025. At around 18.50 hrs we arrived at Kalam Jote area and inquired a person regarding special drive and at that time three persons namely (1) Bimal Barman, s/o -Bishatu Barman, (2) Ujjal Biswas s/o – Shyamal Biswas & (3) Bikram Barman, s/o – Bishatu Barman all are resident of Kalam Jote near Shantiniketan Apartment, PO - Sushruta Nagar, PS -Matigara, Dist - Darjeeling came there and used slang language to us. After that we disclose our identity to them but they became furious and after that they along with 1] Kalpana Biswas (F/50) W/O- Shyamal Biswas, of Kalamm Jote near Shantiniketan Apartment, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (2) Archana Barman (35), w/o - Bimal Barman, of Kalamm Jote near Shantiniketan Apartment, PO - Sushruta Nagar, PS - Matigara, Dist -Darjeeling & (3) Madhabi Biswas, w/o - Ujjal Biswas, of - Kalam Jote near Shantiniketan Apartment, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling (4) Biplab Barman S/O- Bimal Barman (5)Tumpa Biswas W/O- Raju Biswas (6) Raju Biswas and others cordoned us and tried to assault us and creating obstruction to discharge Govt. duty. On protest, they became more furious.

Accordingly, I informed the matter to Officer In-charge NBMC OP, under Matigara PS, SPC and noted the fact in GD vide NBMC OP GDE No 903 Dated. 25.07.2025 and as per his kind order ASI Nayan Kr Das, ASI Amal Roy & ASI Prembhakta Mallick along with forces arrived to the spot. After that we together tried to pacify them but suddenly (1) Bimal Barman, s/o – Bishatu Barman, (2) Ujjal Biswas s/o – Shyamal Biswas & (3) Bikram Barman, s/o – Bishatu Barman all are resident of Kalam Jote near Shantiniketan Apartment, PO – Sushruta Nagar, PS –

Matigara, Dist – Darjeeling (4) Biplab Barman S/O- Bimal Barman (5)Tumpa Biswas W/O- Raju Biswas (6) Raju Biswas and others started assault me and ASI Nayan Kr Das with bamboo one gold chain from me which I wear on my neck and ran away from the spot (except above noted three arrested persons) and later the above noted three women started assault me and Nayan Kr Das and suddenly one of them hit me on my left side of eye. They pushed ASI Nayan Kr Das and he fall down on concreat road and started to assault him badly on his person. They assault us with the intention to kill us but somehow other officer and forces and local people rescue us from their hands. As a result I and ASI Nayan Kr Das received injury on our persons.

Having no alternative way to maintain law and order situation at the area I arrested above noted three accused persons with the help of lady forces. After that I and ASI Nayan Kr Das medically treated at NBMC & Hospital.

Under the above facts and circumstances I pray before you that a specific case under proper section of law may kindly be started against the above noted accused persons namely 1] Kalpana Biswas (F/50) W/O- Shyamal Biswas, (2) Archana Barman (35), w/o – Bimal Barman (3) Madhabi Biswas, w/o – Ujjal Biswas, , (4) Bimal Barman, s/o – Bishatu Barman, (5) Ujjal Biswas s/o – Shyamal Biswas & (6) Bikram Barman, s/o – Bishatu Barman (7) Biplab Barman S/O- Bimal Barman all are resident of Kalam Jote near Shantiniketan Apartment, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling (8) Tumpa Biswas W/O- Raju Biswas (9) Raju Biswas and others and arrange for its investigation.
