Sir,

With due respect and humble submission I, SI Malay Kr. Roy of Bhorer Alo PS, SPC would like to lodge this written complaint against the arrested accused person namely Digen Roy (M/52 Yrs) S/o- Lt. Kanai Roy of Sudamgach, P.O- Kamarvita, PS- Bhorer Alo, Dist- Jalpaiguri after producing the following seized articles with proper seizure list viz:

(i) Seven (07) sealed Bottles of INDIA MADE LIQUOR 60 up each bottle containing 600ml each style as 'Galaxy Boss' bottle by Galaxy C.S Bottling plant Nagrakata, Jalpaiguri [Total 07X 600 ml = 4.200 Litres], Rs 160 each (Amounting of Rs. 160/-X 07 =Rs 1120/-) marked as "Exhibit-A" out of which one bottle is taken as sample and marked as "Exhibit-A-1", (ii) Ten (10) sealed Bottles of INDIA MADE LIQUOR style as 'Galaxy 70 up Oye Oye' bluded & bottled by galaxy CS Bottling plant Nagrakata, Jalpaiguri MRP Rs- 40/- each, each bottle containing 300 Ml. [Total 10X 300 ml = 3.000 Litres], (Amounting of Rs. 40/-X 10 =Rs 400/-) marked as "Exhibit-B" out of which one bottle is taken as sample and marked as "Exhibit-B-1" to the effect that today on 15.07.2025 at about 05:05 hrs myself along with force while performing my Night Mobile Van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 889 Dated 24.07.2025 during Night Mobile van duty when we reached at Kamarvita. under Bhorer Alo PS area at that time found one person carrying huge quantity of illicit liquor on a lylon bag. Accordingly we apprehended him and on interrogation he stated that the above noted illicit liquor to sell the same at Bhorer Alo PS area.

On further interrogation he stated that he used to sale the 60 up 'Galaxy Boss' and 'Galaxy 70 Up Oye Oye' to the owners at different areas under Bhorer Alo Police Station without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search (i) Seven (07) sealed Bottles of INDIA MADE LIQUOR 60 up each bottle containing 600ml each style as 'Galaxy Boss' bottle by Galaxy C.S Bottling plant Nagrakata, Jalpaiguri [Total 07X 600 ml = 4.200 Litres], Rs 160 each (Amounting of Rs. 160/-X 07 =Rs 1120/) and (ii) Ten (10) sealed Bottles of INDIA MADE LIQUOR style as 'Galaxy 70 up Oye Oye' bluded & bottled by galaxy CS Bottling plant Nagrakata, Jalpaiguri MRP Rs- 40/- each, each bottle containing 300 Ml. [Total 10X 300 ml = 3.000 Litres], (Amounting of Rs. 40/-X 10 =Rs 400/-) were kept at nylon bag which he was carrying. On being interrogation he disclosed his name & identity as Digen Roy (M/52 Yrs) S/o- Lt. Kanai Roy of Sudamgach, , P.O- Kamarvita, PS- Bhorer Alo, Dist- Jalpaiguri and on further enquiry it could be learnt that he has been involved in selling and possessing of illicit liquor without any valid license since few months for his wrongful gain. The said accused person namely Digen Roy has violated the norms of Bengal Excise Act. Accordingly Then I, seized and labeled the above mentioned articles under proper seizure list in presence of witnesses and subsequently arrested the above mentioned person namely Digen Roy after observing all the formalities. The whole process of seizure and label has been made in between 05.31 hrs to 05.45 hrs.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Digen Roy (M/52 Yrs) S/o- Lt. Kanai Roy of Sudamgach, , P.O- Kamarvita, PS- Bhorer Alo, Dist-Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.
