Sir,

I SI Sailesh Subba of Bhorer Alo Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the accused person namely Rajak Islam @ Fuchu (M/28) s/o Faridul Islam of Suryasen Colony, Near Suryasen Prathmik Vidyalya, Ward No 34, P.O + P.S NJP, Dist. Jalpaiguri after producing him under arrest and following articles as per Seizure list viz:

1. One (01) improvised handmade one shutter fire arms (Katta) 26 cm (approx.) in diagonal length having barrel, trigger, safety case, firing pin, firing hammer and butt marked as "Exhibit A"
2. One (01) round live ammunition having length 07 cm (approx.) in which 8mm KF was inscribed in its base marked as "Exhibit B".
3. One blue color printed (+120 MICRON) plastic pouch marked as "Exhibit C" where "Exhibit -A" and "Exhibit- B" was kept inside.

In this regard I beg to complain that on 25.07.2025 at about 09.35 hours received a secret source information that one notorious criminal of Siliguri possessing fire arms is coming towards Ambari Bazar under Bhorer Alo PS, SPC from Canal More side suspected to commit heinous crime. Accordingly the matter was diarised vide Bhorer Alo PS GDE No: 909, Date. 25.07.2025 and informed the matter to Officer In Charge of Bhorer Alo Police Station and as per his direction myself along with ASI Utpal Das, ASI ASI Rana Jadav, Const- 322 Jayanta Roy, NVF 29 Kiran Roy all of Bhorer Alo PS left for Nawapara More under Bhorer Alo PS, SPC to work out the information.

At about 09.40 hours we reached at Anchal More and keeping our Police vehicle in road side we laid ambush near Korotwa Bridge and waited for the said accused person to come. On the way I called two independent witnesses namely Dipu Biswas s/o Gopal Biswas of Kamarvita, Mohmaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri and 2] Khokan Paul s/o Amil Paul of Baribhasa, Near Hindi High School, PO Dakshin Shantinagar, PS NJP, Dist. Jalpaiguri/ At present- Anchal More, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri, and shared the information in hand and requested them to accompany with Police team during raid. At about 10.05 hours being identified and shown by my source we saw one person walking towards Korotwa Bridge suspected to be possessing fire arms in his left side waist. Subsequently we started following the said person who was walking towards Korotwa Bridge and managed to apprehend him. We detained him and conducted a thorough search of his body and during his search we found one improvised arms and one live ammunition as noted above which was kept on the left side of his waist. On interrogation the detained accused person disclosed his name and address as noted above. On further interrogation he disclosed that he along with his co-accused namely Bipul Malo s/o Biplab Malo of Ambari, Business Colony, PS Bhorer Alo, Dist. Jalpaiguri has procured the said arms from one unknown person at Islampur. On demand he failed to produce any licence or valid documents for carrying such fire arms in his possession.
