

Sir,

In producing herewith two arrested accused persons namely (1) Rudra Prakash Bhandari-38yrs s/o Lt Chandra Singh Bhandari of Upper Bhanunagar, near Bajaj Showroom, Ward No-43, PS - Bhaktinagar Dist - Jalpaiguri (Ph-8695846510) and (2) Diwas Chhetri-19yrs (Ph-9332530021) s/o Gopal Chhetri of Somesrinagi, PS Dentam West Sikkim (Not verified) along with the following seized articles under seizure as per seizure list:

- (i) 25 (Twenty five) Bottles of PHENSEDYL Cough Syrup each bottle containing 100 ML having Composition, Triprolidine Hydrochloride 1P 1.5mg, Codeine phosphate IP 10 mg (Total weight 25pcs X100 ML=2500 ML = 2.5 Ltrs)
- (ii) One blue and white colour DIO Scooty having Registration No-WB74AW/2374
- (iii) One Black colour i-phone having IMEI No-350355613221724 with sim no-9332530021
- (iv) One Samsung Galaxy mobile A13 phone phone having IMEI No-351204853054552 & 353086183054552 with sim no-8695846510 & 7479075950 of Rudra Prakash Bhandari
- (v) One backpack (SL no-i was kept in SL no-v)

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 26.07.25 at about 22.15hrs, received a reliable source input that two male persons were standing at Salugara, NH-10 near Thute bazar under Bhaktinagar PS with huge quantity of illegal cough syrup for delivering the same to their designed customers at Salugara area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 1701 dated 26.07.25 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 22.25 hrs myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Mishra, ASI Khagen Barman, Const/374 Debraj Biswas, all are Bhaktinagar PS with investigation kit left for Salugara, NH-10 near Thute bazar under Bhaktinagar PS by govt vehicle to verify the veracity of the information also informed PS night van officer ASI Ratan Sarkar (K-37) to immediate attend at Salugara. This refers to Bhaktinagar PS GDE no. 1702 dated 26.07.25 and M.C.C No- 3753/2025 Dated 26.07.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 22.40 hrs we reached at Salugara, NH-10 near Thute bazar PS Bhaktinagar and meanwhile called two independent witnesses namely; (1) Narajit Roy-30yrs s/o Lt Tiken Roy of Roy colony, Chayanpara, ward no-42, PS Bhaktinagar Dist Jalpaiguri (ph-8101299861) and (2) Dipak Kumar Roy-30yrs s/o Anil Kumar Roy of Kholachand Fapri,

PS Bhaktinagar Dist Jalpaiguri (Ph-8191964773) and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. After sometime waiting there and being accompanied by source and the witnesses our whole police party detained two male persons at Salugara, NH-10 near Thute bazaar, PS Bhaktinagar with a DIO Scooty having Registration No- WB74AW/2374. We disclosed our identity and the information in hand and stated them that they will be searched in persons for the purpose. At this, they disclose their name and address as noted above. On being asked they admitted that they have illegally possessed Cough syrup in their possession for selling the same to his designed customers as per requirement for their wrongful gain. They are stated that some cough syrup was kept in the dickey of their Scooty.

I then gave an option in writing whether they are willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return they given in written reply that they are willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station to come to Salugara, NH-10 near Thute bazar PS Bhaktinagar requested him to presence during search and seizure of the Cough syrup. Accordingly at 23.15 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities and recovered the above noted articles from the possession of above noted accused persons which was kept in their dickey of their scooty. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazetted Police Officer the detained persons failed to produce any valid document in support of possessing of the cough syrup.

Thereafter, I recovered one back pack from the dickey of their scooty containing with total 25 (Twenty five) bottles of PHENSEDYL Cough Syrup each bottle containing 100 ML having Composition, Triprolidine hydrochloride 1P 1.25mg, Codeine phosphate IP 10 mg (Total weight 25pcs X100 ML=2500ML = 2.5 Ltrs) which was kept inside in above noted bag. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and accused persons. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between dated 26.07.25 at 23.30 hrs to dated 27.07.25 at 00.40 hrs.

Being further asked, the apprehend persons namely (1) Rudra Prakash Bhandari-38yrs s/o Lt Chandra Singh Bhandari of Upper Bhanunagar, near Bajaj Showroom, Ward No-43, PS - Bhaktinagar Dist - Jalpaiguri and (2) Diwas Chhetri-19yrs s/o Gopal Chhetri of Somesrinagi, PS Dentam West Sikkim admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that they procured the cough syrup clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of cough syrup illegally for last few months.

Then, I arrested the above noted accused persons namely (1) Rudra Prakash Bhandari-38yrs s/o Lt Chandra Singh Bhandari of Upper Bhanunagar, near Bajaj

Showroom, Ward No-43, PS - Bhaktinagar Dist - Jalpaiguri and (2) Diwas Chhetri-19yrs s/o Gopal Chetri of Somesrinagi, PS Dentam West Sikkim after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS and ground of arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely (1) Rudra Prakash Bhandari-38yrs s/o Lt Chandra Singh Bhandari of Upper Bhanunagar, near Bajaj Showroom, Ward No-43, PS - Bhaktinagar Dist - Jalpaiguri and (2) Diwas Chhetri-19yrs s/o Gopal Chhetri of Somesrinagi, PS Dentam West Sikkim and arrange for its investigation.
