In producing herewith the accused person named Buchu Majhi, aged 29 yrs, s/o- Shankar Majhi, resident of Bhujiapani, Dumriguri, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 5573 3932 6775) under custody along with following seized articles under proper seizure list:

1. Ten (10) ltrs 'Chullu' in one plastic jar of 10 liters and marked as Exhibit-A.

2. Eight (08) bottles of "PRAKASH60 60" UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.

(Total 14.8 ltrs, total value Rs. 1280/-)

BOR P.S LANC I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Buchu Majhi, aged 29 yrs, s/o-Shankar Majhi, resident of Bhujiapani, Dumriguri, PS- Bagdogra, Dist- Darjeeling to the effect that on 25.07.2025 at around 17:05 hrs in course of performing PC Mobile van duty vide Bagdogra PS GDE No. 1141 dated 25.07.2025 I received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect named Buchu Majhi located at Bhujiapani and the same has been selling illegally from that house cum shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, C/1509 Sourav Roy Sarkar, CV/389 Janak Singh & CV/375 Jogesh Barman left for Bhujiapani under Bagdogra PS, SPC to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 17:20 hrs we reached at Bhujiapani and being indication & identification by source we held raid at the house cum Officer-in-change of the suspect Buchu Majhi and managed to apprehend the suspect with the help of Officer-iri-Caccompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Bagdogra P Buckeol Majhi, aged 29 yrs, s/o- Shankar Majhi, resident of Bhujiapani, Dumriguri, PS- Bagdogra, Siliguri Metropolitan Darjeeling (Aadhaar No. 5573 3932 6775) who introduced himself as the owner of that house cum shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two local people named Babulal Majhi, 28 yrs, s/o- Late Rohora Majhi, r/c- Bhujiapani, Dumriguri, PS- Bagdogra, Dist- Darjeeling and Bimal Majhi, 34 yrs, s/o- Late Subal Majhi, r/o- Bhujiapani, Dumriguri, PS-Bagdogra, Dist- Darjeeling agreed to be present there as independent witness. Then, we searched the house cum shop of the suspect Buchu Majhi in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Buchu Majhi (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 17:23 hrs and 17:40 hrs on 25.07.2025 through audio-video electronic means using mobile phone and then the same audiovideo record is converted to a pen drive using computer system.

> Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person Buchu Majhi, aged 29 yrs, s/o- Shankar Majhi, resident of Bhujiapani, Dumriguri, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 5573 3932 6775), and arrange for its investigation.
