## Sub: - F.I.R.

In producing herewith the accused person named Prem Bahadur Gurung, aged 70 yrs, s/o-Late Ram Bahadur Gurung, resident of Daragaon, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 2812 3140 9533) under custody along with following seized articles under proper seizure list:

1. Five (05) ltrs 'Chullu' in one plastic jar of 05 liters and marked as Exhibit-A.

2. Six (06) bottles of "PRAKASH60 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.

3. Four (04) bottles of KINGFISHER Imperial Strong Beer, each contains 650 ml @ Rs. 135/-, out of which 01 bottle is taken out as sample and marked as Exhibit-C.

(Total 11.2 ltrs, total value Rs. 1500/-)

I, ASI Amit Lama of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Prem Bahadur Gurung, aged 70 yrs, s/o- Late Ram Bahadur Gurung, resident of Daragaon, PS- Bagdogra, Dist- Darjeeling to the effect that on 25.07.2025 at around 17:15 hrs in course of performing PC Mobile van duty vide Bagdogra PS GDE No. 1141 dated 25.07.2025 I received reliable source information that a huge quantity of liquor is stored at the tea stall of one suspect named Prem Bahadur Gurung located at Bagdogra Bihar more underpass opposite to Bengdubi Army Gate and the same has been selling illegally from that tea stall for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, C/1509 Sourav Roy Sarkar, CV/389 Janak Singh & CV/375 Jogesh Barman left for Bagdogra Bihar more underpass opposite to Bengdubi Army Gate under Bagdogra PS, SPC to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 17:30 hrs we reached at Bagdogra Bihar more underpass opposite to Bengdubi Army Gate and being indication & identification by source we held raid at the tea stall of the Suspect Prem Bahadur Gurung and managed to apprehend the suspect with the help of Officer-incompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Bagdogr Prom Bahadur Gurung, aged 70 yrs, s/o- Late Ram Bahadur Gurung, resident of Daragaon, PS-Bagoos Dargeling (Aadhaar No. 2812 3140 9533) who introduced himself as the owner of that shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two local people named Kul Prasad Sharma @ Ujjal, 34, Late Om Prakash Sharma, r/o- Daragaon, PS- Bagdogra, Dist- Darjeeling and Trinath Bisai, 32, Late Pritambar Bisai, r/o- Pramod Nagar, PS- Bagdogra, Dist- Darjeeling agreed to be present there as independent witness. Then, we searched the tea stall of the suspect Prem Bahadur Gurung in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that tea stall. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his tea stall since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Prem Bahadur Gurung (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 17:34 hrs and 17:55 hrs on 25.07.2025 through audio-video electronic means using mobile phone and then the same audiovideo record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person Prem Bahadur Gurung, aged 70 yrs, s/o- Late Ram Bahadur Gurung, resident of Daragaon, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 2812 3140 9533) and arrange for its investigation.
