Sir, With due respect I, Smt. Renu Ram alias Renu Ram Pandit, Wife of Santosh Pandit and Daughter of Sri Shankar Ram presently residing at my father's home viz Shankar Ram House, Demdema Basty, Salugara, P.O. Salugara, P.S. Bhaktinagar, Jalpaiguri, Pin 734008, beg to lodge this complainant to your end to the effect that my marriage was solemnized and registered on 14.07.2017 before the Marriage Registrar, Jayanti Paul, Dist. Jalpaiguri with Sri Santosh Pandit, Son of Late Ram Prasad Pandit, resident of Coronation valley, C block, 101, Demdema (Mobile No. 9933853007). As soon as the marriage was done, my husband took me to a rented flat at Shivmandir where we intimated out of love and being happy of getting married. But suddenly after few hours, he asked me to leave and go to my paternal home and said that once social marriage is done only thereafter, we shall stay together, so I went to my mother's house. After one week my husband called and said due to some treatment purpose, I need to go with him Kolkata, thereafter I asked my father about the same and he granted me to go as being his wedded wife. On reaching Kolkata he took me to IVF clinic, which came out as a shock to me. I being a 23-year-old woman not married for long, without my knowledge my husband bought me to an IVF clinic. I told him why he bought me here on which he replied that he is having some issue in his body because of which I won't be able to conceive naturally.

I kept mum and acted as per the instruction provided. We both returned to Siliguri and on the same night I came to know that I am pregnant. That on knowing the same my father arranged our social marriage at Charmuni Tea estate Temple on 22.05.2017 after marriage my inlaws does not took me to their house rather I and my husband alone went to the Said rented flat at Shiv mandir which was quite uncomfortable for newly wedded girl. Even my parents were not happy with the reluctant attitude of my inlaws.

That few just days thereafter, suddenly one morning he told me to get ready so that he can send me to my mother's place. On questioning about the same he said few relatives are coming so I need to leave which was quite shocking and suspicious for me. He left me to my mother house for three four days but he was not taking me back. On calling multiple times, he answered and I went back, later I came to know that some relatives of his previous wife has come over to which I questioned

a lot as he has informed me and my parents that he is already divorced with the exwife.

During pregnancy period, he frequently used to go Bihar (Patna) on asking about the same he said he is visiting his sister at Bihar later I came to know that every time he went Bihar, he went to meet his earlier wife and pay her good amount of money. But ignoring the same I kept quiet for protecting my marriage. On delivery of my baby boy, he for the first time took me to my inlaws house at Bagrakote but did not allow me to talk to any person nearby not even his cousin brothers and their wives. In the year 2019 when I delivered my baby girl, suddenly his ex-wife on the occasion my daughter's naming ceremony turned up and I was introduced to her. Her ex-wife, Supriya Pandit (Sudha Pandit) took to me a corner and said that she has not divorced my husband yet, further she said me that she wants to stay with my husband and my kids as part of my family, I was left with no words. I asked my husband to send them back immediately to which my husband attitude was not good. Next day I returned Salugara, my husband called and said that his ex-wife is asking for one my child which being a mother is impossible to give. I was in mental shock and trauma already because of my husband, as he cheated on me and my family telling that he is already divorced. Everyone in our society was told the same lie by my husband. It is important to mention that while I was in Saluagara with my two child, my husband's ex-wife stayed almost about 20 days with my inlaws and she used to call my husband frequently. It is only then me and family came to know that his entire family is involved in this, and for that reason only he never arranged any social ceremony to introduce me and our children in the society. I did not complaint about the same to the police as I already had two children by then, for the sake of their future I compromised and stayed with him.

That a meeting was held with my family and it was decided that he shall give divorce to his earlier wife and shall stay with me taking flat at Salugara. A flat was taken and I along with my children were shifted at the flat. That in the year 2022 my inlaws shifted at my flat and then the real torture started. My mother-in-law used to mock me every now and then about my cast, also stated my father gave nothing as dowry etc. That they left our flat after 6-7 months and went bagrakote on request of my husband. That my husband used to frequently beat me and assault me in front my children. Many times, he provoked me to commit suicide and pretended in front of the society that I am a psychic patient and took me multiple times to psychiatrist and forced me to took medicines. Having no option, I went to my mother-in-law about telling her about his son's deed but she refused and started yelling at me and came to beat me to which I responded and hit back. Thereafter my mother-in-law went to police station to lodge complaint against me

which was denied as on investigation as it was clear that my mother-in-law intentionally did all this.

My husband was staying Dhupguri for work purpose and used to visit on weekends generally. That with passing years things got worsened and his torture became unbearable. Later, he stopped paying home loan EMI, Car EMI and many other loan EMI which he has taken few of which are in my name and that too without my knowledge. He stopped receiving my calls, being compelled I went Dhupguri and asked him my share to fed my children and pay loans. He fought at Dhupguri with me, and then came back to Siliguri and sold all of my ornaments & paid his EMI and now he stopped providing me with basic necessities and has asked me to earn if I want anything. I became subject of regular ill treatment, physical and mental torture, abuse, pain by my husband. My husband started to torture me in various in-human ways/methods and mother-in-law calls my husband as to share the news how he tortured me.

I became tremendously depressed due to such mental as well as physical abuse by my husband. My husband threatened me with dire consequences if I disclose the said actions to police. My husband never bothered to care about me even when I was pregnant with my third child during that period also, he used to force me to intimate with him, which is absolutely painful. He taunts me every now and then that I have not bought any thing from my father's home. Recently he was demanding shop of father to which my father denied to provide. On listening the same he beat me brutally to which my neighbors informed by brothers that my husband is beating me, so one of my brothers (Naresh Ram) came to protect me but when I saw he is having Khukri in his hand I asked him to leave but in return my husband went outside and beat him with said khukri. My second brother (Bharat Ram) saw this while working outside with carpenters and took my injured brother to hospital.

That yesterday i.e. 26.07.2025 one my neighbor's uncle visited my house along with my neighbor and her brother who asked me whether they can stay at my place for a day or two to which I being very close to them permitted them. My husband during the day visited and saw them and asked me who are they to which I said everything in detail. At night about 8.00 to 8.30 p.m. me and my neighbor were preparing dinner in my kitchen for said uncle during which suddenly my husband entered and took a saw and started beating me and that uncle saying all illicit words for us. He also misbehaved with my neighbor, Shabnam (aged about 19 years) and said her that whether she will sleep with him in front of his uncle. After which he started beating me like a psychic, my husband brutally misbehaved, ill-treated and beaten me to the extent of life taking just because of his inferior thinking. My legs were completely in blood and in that condition my husband

called my parents and said them that I am staying here with some other persons and he ran away. My brothers took me to the hospital for treatment, I have got two stitches on my leg and I am unable to walk because of the said assault and torture.

Being compelled and having enough of continuous mental torture, ill treatment and physical abuse made by my husband upon me, I am lodging this complaint against my husband to arrest him & prosecute him according to law and also do needful justice in favour of me.
