When I protest against him they all attacked upon me and my son there name is 1. Umesh Mahato 2. Dipak Mahato 3. Soni Mahato 5. Indu Mahato 6. Rabindra Mahato 7. Santosh Mahato,

One of them Mr. Umesh Mahato attacked upon me with sharp weapon knife and take a Oppo mobile phone and Rs.10,000/- (Rupees Ten Thousand) with forcefully and they all runways.

Sir, they all are very dangerous person and I and my family member very scared from him.

Thereafter some local people take me and send me to the District Hospital of Siliguri for the treatment by TOTO, thereafter in the

Hospital the Doctor said that you immediately admitted in Hospital otherwise he will be died therefore my relative admitted me in the Districk Hospital of Siliguri.

Thereafter two days complete my treatment the Doctor discharges me today i.e. 27/07/2025 from the Hospital.

So, finding no other alternative I approach before you to kindly direct the positive investigation of this case against the all local gundas and their family and take necessary action against them.

And for this act of kindness, I shall remain extremely gratefully to you.
