This is to bring to your kind notice that I Sri Abhisekh Ray S/o Lt Shibu Ray, from Paschim Harmati, Barakamat, Maynagar was visit to Fiorangi club Seroke Road along with my friend Rananjay Gupta Ray for leisure and recreation.

We reached the club at 12:30 AM on 27.7.25 in my car and was at the parking place. Our common friend Miss Shreyasi Roy who was in the club came to the parking lot to receive us. At this time a group of strangers consisting of 3/4 men who are totally unknown to me started to use abusive language at me claiming that I owe a large sum of money to them which is totally false and fabricated. I was surprised and provoked to their misbehaviour and claim trying to make them understand that there surely has been some mistake on their part. But they were seemingly under the influence of some intoxication and then one of them slapped me hard and all of them kept on threatening me and my friend and also tried to rob me of my belongings which hurt me a lot. Also my friends came to my rescue and pleaded with them to spare me. But they started to threaten them with dire consequences and kept on dragging and pushing me.

one of them even threatened to pull out a gun if my friends did not go away from the place leaving me in their hands. When my friends kept on pleading and also said that we would be forced to call the police even after that they intimidated to kidnap us and take us forcibly away from there. Somehow we could contact the Bhaktinagar PS and the police team reach the place of occurrence very shortly but hearing the sound of the approaching vehicle the miscreants left the place in their vehicle in a hurry with threats to harm us in future. The vehicle number as noted is - WB 73 H - 0933 it is a AZIRE VXI vehicle of white colour maruti SUZUKI. From certain by standers we came to know that this persons were one - Pemba Tamung, Manab Ghosh and Subham who frequented the place often and disturbed people who came to the club trying to extort from victims through threat said by the club owner Ankur.

So, If not for the police reaching in time I and my friends would have been in mortal danger from this outlaws who physically assaulted me, tried to rob me of my belongings, used constant abusive language on all of us, threatened all of us of using firearms on us, and also threatened to kidnap us all. It noted there is a CCTV camera in parking lot which may be checked for details.

The complain may kindly be treated as an FIR and a proceeding started accordingly to nab the criminals.
