Subject: Complaint regarding assault and attempt to murder

Respected Sir,

I, Dr. Agnivo Bandopadhyay, am a law-abiding citizen residing on the first floor of a bungalow located at Block D1, House 09, 1st Floor, Uttorayan Township, Matigara, West Bengal - 734010, I would like to lodge the following Complaint:

On 27.07.2025 between 1:00 A.m to 1:30 A.m, Abhishek Singh who resides on the ground floor of the same bungalow. The said person has also set up his professional chamber on the ground floor premises and initially held a position of trust with me as he was engaged to handle a legal case on my behalf.

However, over time, he began unjustifiably demanding large sums of money from me. I had to terminate our professional relationship and formally disengage by obtaining a No Objection Certificate (NOC) from him.

Subsequently, the said person began misusing the premises under the guise of running an office. He started consuming ganja regularly and was seen bringing ~~people~~ ^{unknown women} into the premises, which severely disturbed the residential atmosphere and caused serious concern to me, given my professional

...ing and personal dignity.

The situation escalated dangerously when, under the influence of alcohol, the accused forcibly trespassed into my first-floor residence and physically assaulted me without any provocation. In an act of self-defence, I was forced to repel him to protect myself from further harm.

Disturbingly, the matter did not end there. After a short interval, the accused returned accompanied by 2 to 3 individuals and among the individuals, one individual name is Vivek Singh who is already involved in a criminal matter. They forcefully broke down the door of my residence, entered my flat without consent and launched a second violent assault on me. During this criminal act, they caused extensive damage to my household belongings, the damages are listed as follows :- i) LG 27inch Ultragear Oled Ghd gaming monitor of Rs. 80,000/- ii) Samsung Curved 4K Smart HDR TV 48inch of Rs. 1,50,000/- iii) Apple TV Remote Specifically the Siri remote of Rs. 12,000/- iv) Gaming Chair of Rs. 18,000/- v) Gaming Setup of Rs. 1,30,000/- vi) Left-side looking glass of my vehicle bearing registration no. WB 74 BJ 9528 of Rs. 3000/- . The accused even vomited inside my room further degrading the living conditions and causing severe humiliation.

Most alarmingly, during this violent confrontation, the accused made a direct and deliberate attempt to end my life. His actions were brutal, targeted, and made

direct and deliberate attempt to end my life.

His actions were brutal, targeted and made with clear murderous intent, which I narrowly escaped through sheer chance and self defensive action. I am convinced that had I not acted to protect myself, the outcome would have been fatal.

Furthermore, the accused issued life-threatening warnings and declared that he would falsely implicate me in serious criminal charges under POCSO and NDPS Acts.

These series of events have left me in a state of extreme fear for my life, mental peace and overall safety.

I now find myself unable to live in my own home without the constant dread of another violent attack.

I earnestly request you to treat this matter with utmost seriousness and urgency. Kindly register a FIR against the accused and the persons involved and initiate appropriate legal action to ensure my safety and justice under the law. I am ready to cooperate fully and provide any further information or documents required for your investigation.
