Respected Sir,

I, Dr. Penzin Dichen Bhutta, am a law-abiding citizen
and a medical professional by occupation presently residing at
Durgaguri, Darjeeling More, Siliguri-734003. I would like to
lodge the following Complaint.

On 26/07/2025 between ~~12:00 AM and 1:00 AM~~, I had gone to visit
my Colleague and friend, Dr. Agnivo Bandopadhyay who had come
from Kolkata. As I was about to leave his residence at
approximately 1:00 A.M., Mr. Abhishek Singh ~~entered~~ entered
the premises and without any provocation began physically
assaulting Dr. Bandopadhyay.

In the course of this Confrontation, Mr. Singh also directed
abusive and vulgar language towards me. He used deeply
offensive and obscene words such as "xandi", "bhenchod",
"madoschod" among other filthy terms, thereby causing extreme
ATTO

...iation and mental agony. His remarks were specifically aimed at demeaning my dignity and reputation as a woman.

He also made serious threats of sexual violence by threatening to rape me and to cut me into pieces, which created an immediate sense of fear for my life and personal safety.

In order to protect myself, I fled to the residence of a neighbour in the same locality. However, even at approximately 5:00 am, when I attempted to leave for my home, Mr. Singh pursued me in his vehicle in a threatening manner. Out of fear for my life, I had to drive away hastily to avoid further danger.

The actions of Mr. Abhishek Singh amount to intentional insult to outrage modesty, use of abusive and obscene language, threats of sexual violence and criminal intimidation. His behaviour poses a direct threat to the safety and dignity of women and reflects a deliberate intention to inflict physical and psychological harm.

humbly request you to take immediate and appropriate action against Mr. Abhishek Singh based on the above facts. I am willing to Cooperate fully with the investigation and can provide further details and witnesses if required.

Kindly acknowledge this Complaint and initiate necessary Proceedings in the interest of justice.
