I, ASI Manoj Majumdar of NJP P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely (1) Sanjoy Kr. Roy (42) s/o Lt. Tolen Chandra Roy of Patchcal guri, PS- NJP, Dist.- JPG, 2) Ajay Sahani (22) s/o Lt. Ramchandra Sahani of Chaturagachh PS- NJP, Dist.- JPG and 3) Rana Dutta (20) s/o Tarun Dutta of Chaturagachh, Cannel, PS- NJP, Dist.- JPG under arrest along with following seizure articles; (i) One Hocky Stick, ii) One iron made shord approx. length 29 inch with wooden but, iii) One Iron Rod approx length 27 inch. Iv) One Iron made Axe approx length 05 inch with bamboo bat, v) One blue colour nylon Rope, vi) One electric rechargeable Torch Light and, in this regard, I beg to report that on 25.07.2025 at 01.15 hrs received secret reliable source information that about 08/09 anti socials being armed with deadly weapons assembled at More Bazar, Surja sen Coloney, Block E, PS- NJP, Dist.- JPG for making preparation to commit dacoity in a house at More Bazar, Suraja Sen colony area under NJP PS. I informed this source Information to I/C NJP PS and noted the information vide NJP PS GDE No. 1261 Dated 25.07.2025. As per the direction of I/C NJP PS, at 01.20 hrs, I along with C/-1462 Sajan Tamang, VP-08 Laxman Roy, VP-13 Jamirul Islam, CV-824 Niru Yadav, CV-297 Putul Roy, along with investigation Kids left for More Bazar, Surja sen Colony, Block E, PS- NJP, Dist.- JPG for working out the information vide NJP PS GDE No. 1260 Dated 25.07.2025 after briefing officers and force properly. At 01.30 hrs we reached at Madani Bazar, Surja Sen Colony, Block E, PS- NJP, Dist.- JPG and kept our vehicle at considerable distance More Bazar under NJP PS I (i) One Hocky Stick, ii) One iron made shord approx. length 29 inch with wooden but, iii) One Iron Rod approx length 27 inch. Iv) One Iron made Axe approx length 05 inch with bamboo bat, v) One blue colour nylon Rope, vi) One electric rechargeable Tourch Light along with force headed towards More Bazar, Surja sen Colony, Block E, PS- NJP, Dist.- JPG . By this time we reached at More Bazar, Surja sen Colony, Block E, PS- NJP, Dist.- JPG as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 08/09 others assembled at the spot making preparation to commit dacoity tonight at More Bazar area under NJP PS. accordingly searched them in presence of witnesses and found (i) One Hocky Stick, ii) One iron made shord approx. length 29 inch with wooden but, iii) One Iron Rod approx length 27 inch. Iv) One Iron made Axe approx length 05 inch with bamboo bat, v) One blue colour nylon Rope, vi) One electric rechargeable Tourch Light were making preparation for committing Dacoity tonight in a house at More Bazar area under NJP PS but others managed to escape from the spot. Accordingly, I seized above noted articles in presence of above mentioned witnesses under proper seizure list duly signed by them the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure was made in between 01.37 hrs and 01.55 hrs dated 25.07.25. The whole search, seizure were made under Videography. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at More Bazar area, but others managed to escape from the spot. From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at More Bazar area under NJP PS. Further, it is to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 08/09 others who fled away, under proper section of law and to cause its investigation.
