In producing herewith One (01) accused person namely Dipankar Sarkar (30) s/o Manoj Sarkar of Baribhasa Madani Bazar PS New Jalpaiguri Dist Jalpaiguri under arrest and one (01) improvised small Fire arms measuring 21 inch in length with trigger, striking hammer, striking pin in working condition with wooden butt marked as Exhibit A".

I, ASI, Nilam Swarnakar of NJP PS, SPC do hereby lodged this written complaint against the arrested accused person namely Dipankar Sarkar (30) s/o Manoj Sarkar of Baribhasa Madani Bazar PS New Jalpaiguri Dist Jalpaiguri.

In this regard, I beg to report that today i.e. on 26.07.25 at 22.10 hrs, I received a specific secret information that one person namely Dipankar Sarkar had been coming from madani bazar side towards Njp station area for committing heinous crime under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the information in General diary vide NJP PS GDE No 1325 dated 25.07.25 and informed the fact to you. As per your kind order and direction myself along with ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Islam all of NJP PS left for NJP side under PS- NJP, with investigation kit to work out the information by Govt. vehicle having no WB 77 4092 to verify the veracity of the information. Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 22.30 hrs we arrived at Jabravira underpass under NJP PS and as indicated by the source we noticed that one person was coming from madani bazar side. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to apprehended him. On interrogation, he disclosed his identity as noted above. As per our source information, he possessed 01 improvised small Fire arm, hence, immediately we searched the person and recovered 01 improvised iron made small Fire arms measuring 21 inch in length with trigger, striking hammer, striking pin in working condition with wooden butt which was kept concealed in the waist under the cover of his shirt. On demand he failed to produce any document in support of the said improvised Fire arm which was found in his exclusive possession. Thus, his involvement in carrying and possessing illegal Fire arm was established, Then I seized the said improvised small Fire arm measuring 21 inch in length with trigger, striking hammer, striking pin in working condition with wooden butt marked as "Exhibit A, under proper seizure list duly signed by the witness namely 1) Dipjyoti Saha (32) s/o Lt Chandra Kanta Saha of

Amnikanagar PO Sahudanhi Hut PS New Jalpaiguri Dist Jalpaiguri 2) Buddha Deb Saha (28) s/o Arun Saha of Surya sen colony Block A PS New Jalpaiguri Dist Jalpaiguri. and acknowledge by the accused person. The search, seizure and label were made in between 22.55 hrs to 23.15 hrs and subsequently I arrested them by preparing memo of arrest and informing him the ground of arrest

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused persons namely Dipankar Sarkar (30) s/o Manoj Sarkar of Baribhasa Madani Bazar PS New Jalpaiguri Dist Jalpaiguri is desperate and dangerous in nature, and he is carrying the said Fire arm with an ill motive to commit heinous crime in the locality. As he willfully violated the regulation of Arms Act, 1, therefore, pray before your good self that a specific case may kindly be initiated against the accused person namely Dipankar Sarkar (30) s/o Manoj Sarkar of Baribhasa Madani Bazar PS New Jalpaiguri Dist Jalpaiguri under proper section of law and its investigation may kindly be arranged.
