Sub: - Letter of Complaint against Md. Jhangir Alam S/o Md. Aminul Islam of Jorpokri, PO- Sahudangi hat, PS - NJP Dist - Jalpaiguri for illegal storing of Domestic Gas Cylinder and Commercial gas cylinder at his rented house.

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

- 1) Total 07(seven) numbers of Hindustan petroleum Domestic Gas Cylinder fully loaded each printed 14.2 gross weight 29.8 Kgs
- 2) Total (03)three numbers of Hindustan petroleum Domestic Gas Cylinder (fully empty) each printed 14.2 gross weight 29.8 Kgs

3)01(One) Piece Hindustan Petroleum Commercial gas cylinder fully loaded

I Inspector Prosenjit Das of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Md. Jhangir Alam S/o Md. Aminul Islam of Jorpokri PO- Sahudangi hat, PS - NJP Dist – Jalpaiguri to the effect that on 26/07/2025 at about 11:30 hrs received a secret source information that one Md. Jhangir Alam S/o Md. Aminul Islam of Jorpokri PO- Sahudangi hat, PS - NJP Dist – Jalpaiguri is illegally storing and selling Domestic LPG and Commercial cylinders i.e. Hindustan petroleum Domestic Gas Cylinder at his rented house for the purpose of selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No.143/25 Dt. 26.07.25 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector SI Raju Sarkar, ASI Arghya Das, L/C 1270 Deeptina Gazmer all of EB, SPC left EB Office to proceed Jorpokri, PO-Sahudangi hat, PS - NJP Dist – Jalpaiguri to execute the information. This refers EB, SPC GDE No. 144 Dt. 26.07.25 and C.C. No. 50/25 Dt. 26.07.25.

At about 13:25 hrs we reached at Jorpokri, PO- Sahudangi hat, PS - NJP Dist and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the house of Jhangir Alam Jorpokri PO-Sahudangi hat, PS - NJP Dist - Jalpaiguri and found that the above noted accused person is storing and selling loaded LPG and Commercial cylinders i.e. HP. On searching, the above noted seized articles have been recovered from his rented house. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Md. Jhangir Alam S/o Md. Aminul Islam of Jorpokri PO- Sahudangi hat, PS - NJP Dist - Jalpaiguri is storing and selling the Domestic and Commercial gas cylinders at his rented house for his wrongful gain. As per local enquiry it came to light that the above noted person storing and selling gas negligently with respect to fire or combustible matter, which

may endanger human life or likely to cause hurt or injury to person at that locality area. Md. Jhangir Alam does not have any valid License/ Permit of dealing /distribution / selling and storing LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1) Md Rafikul (41yrs) S/o Bhabiruddin of of Jorpokri, PO- Sahudangi hat, PS - NJP Dist - Jalpaiguri. 2. Aamir Hamza (22) S/o Md. Musa of of Jorpokri, PO- Sahudangi hat, PS - NJP Dist - Jalpaiguri. The seizure was made in between 13:45 hrs to 14:15 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Md. Jhangir Alam S/o Md. Aminul Islam of Jorpokri, PO- Sahudangi hat, PS - NJP Dist - Jalpaiguri U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
